Under the terms of agreement, 50% of the seats in the Self financing Professional institutions will be filled up from the list prepared by the Commissioner for Entrance examinations in accordance with the 'merit cum means' basis and the reservation principles followed by the Government from time to time.

50% of the seats (i.e., 35% management seats and 15% NRI seats will be filled up by the Managements concerned as per the terms of agreement entered into with the managements.
