SECOND ALLOTMENT PUBLISHED

The second allotment to various Professional Degree Courses has been published.

The course and college allotted to the candidates, fee to be remitted and other details are available in the website <http://www.cee.kerala.gov.in>. Candidates who have to remit Fee/Caution Deposit as per this allotment can remit the same at any one of the selected branches of Canara Bank on 19th, 20th or 22nd (up to 3 pm) **September, 2007**. The allotment and all higher order options in the particular stream will be cancelled in the case of candidates who fail to remit the fee within the stipulated time.

The candidates allotted to various courses have to report at the colleges between **24.09.2007** and **25.09.2007**, failing which their admission and higher order options in the stream concerned will be cancelled. The joining time will not be extended under any circumstances.

Candidates who took admission as per the allotment published on 01.09.2007 and now re-allotted to a different college / course have to join the respective college/course after remitting the required fee/caution deposit if any, on the dates mentioned above, failing which they will lose their admissions and the higher order options in the stream concerned.

The college authorities can download the list of candidates to whom Transfer Certificate have to be issued from their college, from the web site at <http://www.cee.kerala.gov.in/capcollege> from 20.09.2007 onwards and they may issue Transfer certificates to such candidates from 20.09.2007 itself.

Candidates newly allotted to Self financing Professional colleges have to execute a bond with the management concerned and the management in turn also has to

execute a bond with the candidates admitted by them regarding the fee of the course [as per G. O (Ms) No. 109/2007/H. Edn, Dated:10.08.2007] during admission. The format of the bonds is available in the website at www.cee-kerala.org. Candidates re allotted from one Self financing college to another Self financing college have to cancel the bonds already executed and to execute fresh bonds at the time of admission. Candidates allotted to Government /Government aided colleges need not submit any bonds.

20.09.2007	Colleges to download the list of candidates from the website for issue of Transfer certificates.
22.09.2007 (5 pm onwards)	Colleges to down load the list of candidates allotted for various courses
24.09.2007 & 25.09.2007	Admission to various courses in the Colleges.
25.09.2007 (5pm)	Last date for furnishing the Non-joining reports by the Principals of all Medical & Dental Colleges
26.09.2007	Last date for furnishing Non-joining reports by the Principals of other Professional Colleges
