ORDER

Government have discussed the matter of allotment of seats and fee to be levied with the Management of Self Financing Colleges conducting Bachelor Degree in Physiotherapy (BPT) course and Agreement has been executed with them for admissions for the year 2008-09.

2. Sanction is accorded to the Commissioner for Entrance Examinations for including the following Self Financing Colleges conducting Bachelor Degree in Physiotherapy (BPT) course who have entered into Agreement with Government in respect of sharing of seats and fee structure for allotment of students to B.P.T course for the year 2008-09 subject to the terms and conditions specified below:-

TERMS AND CONDITIONS

- 1. 50% of the total seats in the above Colleges will be filled up by the Government from the list prepared by the Commissioner of Entrance Examinations in accordance with merit and reservation principles followed by Government from time to time.
- 2. 20% out of the above 50% seats in the institution having minority status will be filled up from the list prepared by the Commissioner for Entrance Examinations from the students belonging to the community which established the member College. Candidates claiming such reservation should produce community certificate from the Village Officer before the Commissioner for Entrance Examinations.
- 3. The Commissioner of Entrance Examinations will ensure that the allotments to all seats as above are filled by allotting students from the list before 31.08.08.
- 4. The fee for the above 50% merit seats will be Rs.30,000/- (Rupees Thirty Thousand only) per annum. Annual tuition fee for candidates belonging to SC/ST/OEC students eligible for educational concession as per G.O.(MS) No.25/05/STSCDD dated 20.06.05 will be paid by Government at the rate of Rs.30,000/- (Rupees Thirty Thousand only). The candidates belonging to SC/ST/OEC shall not remit fee during the allotment process. However such students have to remit an amount of Rs.100/- (Rupees Hundred only) as token for accepting the allotment.
- 5. 35% of the total seats in the Colleges will be filled up by the Management from the candidates satisfying the academic eligibility condition as per the Prospectus 2008 and qualified in the Medical Entrance Examination 2008, conducted by the Commissioner for Entrance Examinations. The admission will be on the basis of the merit list prepared according to the percentage of marks obtained for the optional subjects in the qualifying examinations from among the applications received by the Member Colleges.
- 6. The fee collected from the students in the Management seats as above in item No.5 will be Rs. 65,000/- (Rupees Sixty Five Thousand only)
- 7. The remaining 15% seats will be filled up by the Management from the eligible students, who are Children or dependents of Non Resident Indians. The fee to be collected from such students will be up to Rs.1,00,000/- (Up to Rupees One lakh only).
- 8. As per the Agreement the Management will not receive cash or kind other than the fee specified.

9. The said Agreement will be submitted by the Government before the Admission Supervisory Committee, Fee Regulatory Committee and also before the Hon'ble Supreme Court of India for approval.

10. The member Colleges will be entitled to collect uniform fee not exceeding the fees fixed by the fee Regulatory Committee in the State from all students excluding those admitted under NRI quota if the Agreement is not approved by the Court or any other competent authority to declare so.

11. The students admitted from 01.09.08 till closing of admission by Commissioner for Entrance Examinations are not bound to pay any liquidated damages to the Management.

3. In the case of any further litigations, the above terms and conditions will be subject to the Court of Law.
