ORDER

In view of Orders of the Hon'ble High Court of Kerala in various Writ Petitions mentioned above, the fee structure applicable to 50% of the seats in Self financing Medical Colleges which is left to Government for filling through Commissioner for Entrance Examination on merit basis and to 35% seats in Self financing Medical College under Management control is fixed as the fee approved by the Fee Regulatory Committee, which is as follows -

The Fee applicable to 50% seats in Academy of Medical Sciences, Pariyaram and Co-operative Medical College, Kochi will be the fee fixed for Government Medical Colleges. The fee in the above two colleges for 35% management seats will be the fee approved by Fee Regulatory Committee, ie- 2.4 lakhs.

The candidates getting allotment shall pay the fees as mentioned above on the basis of orders of the Hon'ble High Court of Kerala.

However, the candidates are liable to pay the fee to be fixed on the basis of the orders of the Hon'ble Supreme Court. Each candidate shall execute a bond with the management of the institution to this effect and the management shall execute an agreement with the candidates to refund the excess fee, if any.

The Commissioner for Entrance Examinations shall make allotment incorporating the fee structure approved by the Fee Regulatory Committee.
