SECOND PHASE OF CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES 2009 PUBLISHED

Facilities were made available for candidates to re-arrange options, cancel options or to register fresh options to new Colleges/Courses, from **26.07.2009 to 31.07.2009**. On the basis of these options the Second Allotment is published herewith. The details of the Second Allotment are available on the website, www.cee.kerala.gov.in

The candidates can get access to the details of the allotment from their home page. Those who are allotted in this Second Phase of allotment should remit the fee, as mentioned in the home page, at the select branches (*list available on the website*) of the State Bank of Travancore (SBT) from **5th to 8th (till 12 noon) August**. Those who have 'NIL' marked against their Fee /Deposit column need not remit any fee at the bank.

The Candidates who remit the fee will have to take admissions at the respective colleges by submitting the documents specified in the Prospectus, on **10th, 11th or 12th August 2009**. Candidates who have already joined MBBS/BDS courses in Medical/Dental Colleges, but who have received allotment now on the basis of higher option, should obtain their TC and other documents from the present College and should report and take admission in the newly allotted colleges.

Candidates allotted to different Engineering courses will have to join the respective colleges as per the date and time given below:

The candidates will lose their allotment and higher order options, if they fail to remit the required fee or fail to join the college allotted to them within the specified time.

Classes for all courses will commence on 17.08.2009.

The candidates allotted to Private Self-financing Engineering Colleges in the Second phase of allotment will not be eligible for further allotments on the basis of higher order options. Those who are allotted to Private Self-financing Engineering Colleges, but do not take admission in the Colleges concerned will get the refund of fees they remitted at the bank. Those who take admission in the Colleges concerned can cancel their admission till **14.08.2009** and they will also get the refund of fees remitted at the Bank. Those who cancel admission at the Private self financing Engineering Colleges after **14.08.2009** will have to remit the entire course fee to get the TC and other documents.

Allotment process will be continued to all courses in Government and Government controlled self-financing colleges and to the Medical, Dental, Ayurveda and Siddha courses in Private Self-financing Colleges.

Those candidates who wish to cancel their present allotment will have to download the format available on the website www.cee-kerala.org. The downloaded form should be filled up and recommended by the Principal of the College concerned and sent to the Commissioner for Entrance Examinations so as to reach **before 5 pm on 14.08.2009**. The allotment of such candidates and their higher order options in all streams will be cancelled. Requests for cancellation of allotments received by fax will not be considered under any circumstances.

The Principals of all institutions should send the list of 'non-joining' candidates **by fax (0471 - 2337228)** to the Commissioner for Entrance Examinations **before 5 pm on 13.08.2009** itself.
