ORDER

The final allotment to Ayurveda and Homoeopathy courses has been published on 04.10.2011 and the last date for joining the institutions allotted to candidates has been fixed as 15.10.2011. The Commissioner for Entrance Examinations, Thiruvananthapuram, in his letter read above, has reported that a few seats in BAMS and BHMS are likely to remain unfilled after 15.10.2011 due to non – joining / non – remittance of fee by allotted candidates. Hence the Commissioner for Entrance Examinations, Thiruvananthapuram has recommended to authorise the Director of Ayurveda Medical Education and the Principal and Controlling Officer, Government Homoeopathic Medical College, Thiruvananthapuram to fill up the vacancies that will remain unfilled in BAMS and BHMS course respectively in the Government/Aided Ayurveda Medical Colleges and the Government/Aided Homoeopathic Medical Colleges, after 15.10.2011.

Government have examined the matter in detail with reference to the connected documents and are pleased to authorise the Director of Ayurveda Medical Education, Thiruvananthapuram and the Principal and Controlling Officer, Government Homoeopathic Medical College, Thiruvananthapuram to fill up the vacancies that will remain unfilled in BAMS and BHMS course respectively in the Government/Aided Ayurveda Medical Colleges and the Government/Aided Homoeopathic Medical Colleges, after 15.10.2011, from
