ORDER

Government have approved for issue the prospectus for admission to Professional Degree Courses (Medical, Agriculture, Veterinary, Engineering & Architecture Courses) for the year 2013, vide G.O read as 1st paper above. The Hon'ble Supreme Court of India vide its judgment read as 2nd paper above issued certain guidelines for the conduct of admission to the professional degree courses. In the circumstances, Government are pleased to amend the prospectus for the KEAM -13, as given below:

The following addition is incorporated as Clause 11.6.8(iii)

The Hon'ble Supreme Court of India has ordered that the admission process for Engineering courses shall be completed by 15 th August 2013. Hence no allotment/admission to Engineering courses for 2013-14 will be made after 15.08.2013.

The following addition is incorporated in Clause 9.7.10(a)

However, the rank list for Engineering courses will be valid till 15/08/13 in compliance of the orders of the Hon'ble Supreme Court of India dated 13/12/2012 in C.A No.9047 & 9048 of 2012.

The Government Order read as 1st paper above is hereby modified to this extent.
