ALLOTMENT TO PROFESSIONAL DEGREE COURSES (EXCEPT MBBS/BDS), KERALA-2014 THIRD PHASE ALLOTMENT PUBLISHED

The Third phase allotment to Professional Degree Courses except MBBS/BDS Courses in Kerala -2014 is published herewith on the website www.cee.kerala.gov.in

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the **third phase allotment memo** and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fee/balance fee. The list of designated branches of SBT is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the third phase allotment memo at any of the designated branches of **State Bank of Travancore** on **24.07.2014** or **25.07.2014** in order to accept the allotment.

The candidates who get a change in allotment in the third phase than that of the second phase should pay the balance fee, if applicable, in SBT on **24.07.2014** or **25.07.2014**. Those candidates who do not remit the fee/balance fee within the stipulated time will lose their allotment and also their higher options. They will be removed from the entire online allotment process for the existing courses/colleges.

The candidates who are allotted to Engineering/Architecture courses in Govt./ Govt. Controlled Self Financing / Private Self Financing Engineering/Architecture Colleges should join the colleges as per the admission schedule published in the website www.cee-kerala.org. The third round will be the last round of allotment to Engineering/Architecture courses under Govt./Govt. Controlled Self Financing/Private Self Financing Engineering / Architecture Colleges. All the students who have an allotment in Engineering/Architecture courses after the third round should join the course/college concerned. Those who get an allotment in the Private Self Financing Engineering/Architecture colleges after the third phase should invariably join the colleges. Otherwise the liquidated damages envisaged as per Clause 12.2.4 of the Prospectus shall be imposed on such students.

Those who are not able to join the Govt./Govt Controlled colleges as per the schedule above may join the colleges on 31.07.2014 FN.

Those who are not able to join the Private Self Financing colleges on 24.07.2014 may join the colleges on 25.07.2014 AN.

All the College Authorities should submit the Non-Joining Report to the Commissioner for Entrance Examinations before 5 pm on 31.07.2014

Note: All the higher order options of the candidates who get allotment/admission in Private Self Financing Engineering/Architecture Colleges after the Third Phase of Allotment will be deleted.
