CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES, KERALA-2015

THIRD PHASE ALLOTMENT PUBLISHED

The third phase allotment to Professional Degree Courses in Kerala -2015 is published herewith on the website www.cee.kerala.gov.in . Allotments to Engineering and Architecture courses only have been done in the third phase.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the third phase allotment memo and produce it before the authorities of State Bank of Travancore (SBT) for payment of fee/balance fee. The list of designated branches of SBT is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the third phase allotment memo at any of the designated branches of State Bank of Travancore on any date from 22.07.2015 to 25.07.2015 and should join the course/college allotted before 5 pm on 25.07.2015.

The candidates who get a change in allotment than that of the previous allotment should pay the balance fee, if applicable, in a designated branch of SBT on any date from 22.07.2015 to 25.07.2015 and should join the course/college allotted as per the third phase allotment memo before 5 pm on 25.07.2015.

Thus all the candidates who have an allotment under Engineering/Architecture courses should join the course/college allotted as per the third phase allotment memo before 5 pm on 25.07.2015.

Those candidates who do not remit the fee/balance fee within the stipulated time and who do not join the course/college allotted within the stipulated time will lose their allotment and also their existing higher options under Engineering/Architecture courses. They will not be considered for further online allotments, if any, under Engineering/Architecture streams.

Note: This allotment is the last phase of allotment to Private Self Financing Engineering/Architecture colleges. Hence the students who get allotment in such colleges should invariably join the colleges allotted, before 5 pm on 25.07.2015. Otherwise they are liable to pay the Liquidated Damages as per clause 12.2.4 (c) of the Prospectus for KEAM-2015.

The higher order options under Engineering/Architecture streams of candidates who are allotted to Private Self Financing Engineering/Architecture colleges shall be deleted after this allotment. However, liquidated damages may not be collected from the students admitted to Private Self Financing Engineering/Architecture Colleges (except Colleges under Kerala Catholic Engineering College Managements Association) who leave the course/college for getting admission in Medical & Allied courses through KEAM-2015. But the fees remitted by such students for the year shall not be refunded.

Candidates are advised to go through the various clauses relating to Liquidated Damages in the relevant Government Orders available in the above website.
