THIRD PHASE OF ALLOTMENT TO ENGINEERING/ARCHITECTURE COURSES

ONLINE OPTION CONFIRMATION IS MANDATORY

The activities related to the third phase of allotment to Engineering/Architecture courses 2015 will begin on 17.07.2015. **In this phase, allotment will be done to Engineering and Architecture courses only. The details regarding the second phase of allotment to Medical & Allied Courses will be notified in due course.** All the candidates who want their higher order options to be considered for this phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, the candidates can re-arrange / delete their higher order options and also register fresh options to the newly added Courses/Colleges from 17.07.2015 to 19.07.2015, 10 pm, through the website www.cee.kerala.gov.in. The allotment on the basis of options received upto 10 pm on 19.07.2015, will be published on 20.07.2015. The candidates who have an allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations in one of the designated branches of the State Bank of Travancore (SBT) on or before 25.07.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, all the candidates should join the course/college allotted.

The detailed schedule for the allotment is furnished below.

17.07.2015	Website opens for Online Option Confirmation and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
19.07.2015 (10 pm)	Time for Online Option Confirmation and re-arrangement/ deletion/addition of options ends
20.07.2015	Publication of Allotment
21.07.2015 to 25.07.2015	In all the courses, candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.
25.07.2015, 5.30 pm	All the college authorities should approve and submit the list of admitted candidates.

Those who do not confirm their options online will not be considered for this phase of allotment. Also their higher order options in Engineering/Architecture streams will be removed and will not be available in the subsequent phases. However, his/her existing allotment in the Engineering/Architecture courses shall be retained if he/she has joined the college as per the second phase allotment.

The allotment to B.Tech Dairy Science and Technology course in College of Dairy Sciences and Technology, Pookode, Wayanad and B.Tech Food Technology course in College of Dairy Sciences and Technology, Mannuthy, Thrissur were withheld in the earlier phases for want of Government sanction. Allotments shall be done to these colleges also in the next phase and

hence facility for filing fresh options to these colleges shall be available along with new colleges/courses.

The Colleges and Courses for which fresh options can be registered in this phase of allotment are furnished below:

Note: The Allotment to be published on 20.07.2015 is the last phase of allotment to Private Self Financing Engineering/Architecture colleges. Hence the students who get allotment in such colleges should invariably join the colleges allotted, before 5 pm on 25.07.2015. Otherwise they are liable to pay the Liquidated Damages as per clause 12.2.4 (c) of the Prospectus for KEAM-2015.

The higher order options under Engineering/Architecture streams of candidates who are allotted to Private Self Financing Engineering/Architecture colleges shall be deleted after this allotment. However, liquidated damages may not be collected from the students admitted to Private Self Financing Engineering/Architecture Colleges (except Colleges under Kerala Catholic Engineering College Managements Association) who leave the course/college for getting admission in Medical & Allied courses through KEAM-2015. But the fees remitted by such students for the year shall not be refunded.

Candidates are advised to go through the various clauses relating to Liquidated Damages in the relevant Government Orders available in the above website.
