**SECOND PHASE OF ALLOTMENT TO MEDICAL & ALLIED COURSES**  
**ONLINE OPTION CONFIRMATION IS MANDATORY**

The activities related to the second phase of allotment to Medical & Allied Courses 2015 will begin on 23.07.2015. The Candidates who want their higher order options to be considered for the second phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange /delete their higher order options and also register fresh options to newly added Courses/Colleges from the evening of 23.07.2015 to 26.07.2015, 3 pm, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) . On the basis of options received upto 3 pm on 26.07.2015, the second phase allotment to Medical & Allied Courses will be published on 27.07.2015. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on any date from 29.07.2015 to 01.08.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college allotted as per the second phase before 5 pm on 01.08.2015. Thus all the candidates who have an allotment in Medical & Allied courses should join the colleges before 5 pm on 01.08.2015. The detailed schedule for the 2<sup>nd</sup> phase of allotment is furnished below.

**SCHEDULE FOR THE SECOND PHASE OF ALLOTMENT TO MEDICAL & ALLIED COURSES:**

23.07.2015 (6 pm)	Website opens for <b>Online Option Confirmation</b> and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
26.07.2015 (3 pm)	Time for Online Option Confirmation and re-arrangement/ deletion /addition of options ends
27.07.2015	<b>Publication of Second Phase Allotment</b>
29.07.2015 to 01.08.2015	Candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.
01.08.2015, 5.30 pm	All the college authorities should approve and submit the list of admitted candidates.

Those who do not confirm their options online will not be considered for the second phase allotment and also their higher options in Medical & Allied courses will not be available in the subsequent phases. However his/her existing allotment shall be retained.

Allotments to three Medical Colleges under Kerala Christian Professional College Managements Federation were withheld in the first phase for want of the letter of permission for the year 2015-16 from Medical Council of India, though online options had been invited for them. But in the wake of the orders of the Hon'ble High Court of Kerala dated 30.06.2015, allotments shall be done to these colleges and hence facility for filing fresh options to these colleges shall be available along with new colleges/courses.

The Colleges and Courses for which fresh options can be registered in the 2<sup>nd</sup> phase of allotment are furnished below:
