**ONLINE ALLOTMENT TO FILL UP THE VACANT SEATS IN MBBS/BDS COURSES-2015**  
**ONLINE OPTION CONFIRMATION IS MANDATORY**

The vacant seats in MBBS/BDS courses after the allotment on 21.09.2015 to MBBS/BDS courses in Government Medical/Dental colleges and two Private Self Financing Medical Colleges (Al Azhar Medical college & Super speciality Hospital, Ezhalloor, Thodupuzha, Idukki and Sree Gokulam Medical College & Research Foundation, Venjaramoodu P O, Thiruvananthapuram) will be filled up through an online allotment which will be published on 27.09.2015.

The higher options of students who are already allotted and admitted in the Self Financing Medical/Dental Colleges shall be deleted and they will not be considered for this vacancy filling phase of allotment as per the various Government Orders relating to Fees and Admission of Students in Self Financing Medical/Dental Colleges. The otherwise eligible candidates who want their higher order options to be considered in this vacancy filling phase of allotment shall have to login to their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange/delete their higher order options from 25.09.2015 to 27.09.2015, 3 pm, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). On the basis of options received up to 3 pm on 27.09.2015, the vacancy filling phase of allotment to MBBS/BDS will be published in the evening on 27.09.2015. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on 28.09.2015 or 29.09.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college before 5 pm on 29.09.2015. **Those who do not confirm their options online will not be considered for this phase of allotment.**

The schedule for allotment is given below:

25.09.2015 (8 pm)	Website opens for <b>Online Option Confirmation</b> and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
27.09.2015 (3 pm)	Time for Online Option Confirmation and re-arrangement/ deletion /addition of options ends
27.09.2015 (8 pm)	<b>Publication of Allotment</b>
28.09.2015, 29.09.2015	Candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.
29.09.2015, 5.30 pm	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS)

This allotment is for filling up the vacant seats in MBBS/BDS courses only and the allotments to other Medical & Allied courses will be notified in due course.

**Important:- This will be the last phase of allotment to the two Private Self Financing Medical Colleges (Al Azhar Medical college & Super speciality Hospital, Ezhalloor, Thodupuzha, Idukki and Sree Gokulam Medical College & Research Foundation, Venjaramoodu P O, Thiruvananthapuram) and also to the Government Medical/Dental Colleges unless otherwise notified. Hence the candidates who get allotments in this phase should invariably join the allotted colleges. Otherwise they are liable to pay the Liquidated damages of Rs.10 lakhs as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2015.**

The Allotment and Admission in Al Azhar Medical college & Super speciality Hospital, Ezhalloor, Thodupuzha, Idukki and Sree Gokulam Medical College & Research Foundation, Venjaramoodu P O, Thiruvananthapuram shall be subject to the result of the Writ Petitions pending before the Hon'ble High Court of Kerala.

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

**Note:** Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to MBBS/BDS Courses only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to MBBS/BDS Courses subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No. 372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
