ORDER

Government have approved the Prospectus KEAM 2015 for Admission to Professional Degree Courses ( Medical , Agriculture , Veterinary , Fisheries, Engineering & Architecture Courses ) for the year 2015 , vide G.O read as first paper above.

As per G.O read as third paper above , Govt. have modified the clause 9.7.5 of the Prospectus for the KEAM 2015 as follows :

“ To qualify in the Entrance Examination and thereby become eligible to figure in the ranklist for Engineering /Medical/Ayurveda , a candidate has to score a minimum of 10 marks each in Paper I and Paper II of the concerned Entrance Examination .The candidates who do not score the minimum stipulated marks will not find a place in the Rank list . Such Candidates will be shown as ' Disqualified' .

Candidates disqualified in Medical Entrance Examination are not eligible for admission to the Medical & Allied courses and candidates disqualified in Engineering Entrance Examination are not eligible for admission to the Engineering Courses.

For SC/ST candidates there is no requirement of minimum marks in the Entrance Examination except for MBBS /BDS courses . There is no change in clause 9.7.5 (I) & 9.7.5(ii) of the Prospectus KEAM 2015 ”

As per letter read as fifth paper above ,the Secretary ,Kerala Self Financing Engineering College Management's Association has requested Government to admit candidates under Management quota from the list (pre -normalisation) by observing merit and reservation ,as followed in the previous years.

Government have examined the matter in detail and approved the proposal for admitting candidates under Management quota from the Pre -normalisation list. Accordingly the G.O read as fourth paper above is modified as follows:

“ To qualify in the Entrance Examination and thereby become eligible to figure in the ranklist in merit seats for Engineering /Medical/Ayurveda , a candidate has to score a minimum of 10 marks each in Paper I and Paper II of the concerned Entrance Examination . The candidates who do not score the minimum stipulated marks will not find a place in the Rank list in Merit Seats .The Self Financing College Management can admit candidates under management quota from the list (Pre -normalisation ) by observing merit and reservation . For such admissions, minimum cut off mark is not insisted ”.

The G.O read as first ,third and fourth papers above are modified to this extent only .
