ORDER

Government have approved the Prospectus KEAM 2015 for admission to Professional Degree Courses (Medical , Agriculture , Veterinary , Fisheries , Engineering & Architecture Courses) for the year 2015 , vide Government Order read as first paper above. As per the Government Order read as 2nd paper above , Government have relaxed the eligibility criteria for admission under Management quota seats in private self financing Engineering colleges by modifying the clause 6.2.2 (a) of the KEAM 2015 . The Director, Institute of Human Resources Development has requested to extend the mark relaxation benefit for Management quota seats in Government Controlled Self Financing Colleges also.

Government have examined the matter in detail and are pleased to change the eligibility criteria for admission under Management quota seats in Self Financing Engineering Colleges by modifying the clause 6.2.2 (a) of the Prospectus for the KEAM 2015 as :

Candidates who have passed Higher Secondary Examination , Kerala , or Examinations recognized as equivalent thereto , with 45 % marks in Mathematics , Physics and Chemistry put together are eligible for admission under Management Quota in Private Self Financing Engineering Colleges / Government Controlled Self Financing Engineering Colleges . The Government Order read as 2nd paper above is modified to this extent only.
