ORDER

As per Government Order read above, the State of Kerala had conducted the Kerala Engineering, Agriculture, Medical Entrance Examinations (KEAM) for admission to various professional Courses including MBBS and BDS for the Academic year 2016-17. However, as per the judgment read above the Hon'ble Supreme Court directed to conduct a National Eligibility Cum Entrance Test (NEET) for admission to MBBS and BDS courses in the country nullifying the Entrance Examinations conducted by the individual States for admission to MBBS and BDS Courses. Now, the Ministry of Law and Justice, Government of India, as per the Ordinances read as 3rd and 4th papers above has exempted the State Government from making admission to MBBS and BDS Courses through NEET in the Government seats only (ie, the MBBS and BDS seats in the Government Medical/Dental Colleges and Government Merit seats in the Self financing Medical /Dental Colleges)

In the above circumstances, the Government are pleased to direct the Commissioner for Entrance Examinations, Kerala, Thiruvananathapuram to publish the KEAM 2016 results in respect of MBBS and BDS courses, and to allot students to the Government seats in Government Medical/Dental Colleges and Self Financing Medical/Dental Colleges. The Self Financing Medical and Dental Colleges shall fill the Management quota seats from the list of eligible candidates prepared based on NEET only.
