## ADMISSION TO MBBS COURSE-2017

The Hon'ble High Court of Kerala vide orders dated 25.08.2017 on WP(C) No. 19753, 27307 & 28258/2017 have directed the State Government to allow the petitioner colleges viz. Al Azhar Medical College & Super Speciality Hospital, Ezhalloor, Thodupuzha, Idukki, DM Wayanad Institute of Medical Sciences, Kalpetta, Meppadi P.O., Wayanad and Mount Zion Medical College, Chayalode, Adoor, Pathanamthitta to participate in the allotment process provisionally subject to further orders in the writ petitions. In the circumstances, allotment shall be done to the above three Private Self Financing Medical colleges during the Spot Admission to be conducted by the Commissioner for Entrance Examinations on 30<sup>th</sup> and 31<sup>st</sup> of August 2017 at the Old Auditorium inside Government Medical College campus, Thiruvananthapuram.

As the seat matrix approved vide GO(Rt) No. 2363/2017/H&FWD, the following minority quota seats in the two colleges viz. Al Azhar Medical College & Super Speciality Hospital, Ezhalloor, Thodupuzha, Idukki and Mount Zion Medical College, Chayalode, Adoor, Pathanamthitta having minority status also shall be filled up in the Spot Admission.

Candidates from the respective minority communities seeking admission to the minority quota seats in the above colleges shall have to produce the required certificates/documents to prove their minority community status at the time of Spot Admission.

Candidates getting allotment to the 85% seats in the above three colleges are required to submit a Demand Draft of Rs. 5 lakhs drawn in favour of the Commissioner for Entrance Examinations, Thiruvananthapuram payable at Thiruvananthapuram along with a Bank Guarantee for up to Rs. 6 lakhs. But as per the orders of Hon'ble Supreme Court dated 28.08.2017, a period of 15 days is granted to submit the Bank Guarantee. Hence candidates do not submit Bank Guarantee at the time of admission are required to submit a Bond for up to Rs. 6 lakhs at the time of admission. Candidates getting allotment to the 15% NRI seats shall have to submit a Demand Draft of Rs. 20 lakhs drawn in favour of the Commissioner for Entrance Examinations, Thiruvananthapuram payable at Thiruvananthapuram at the time of Spot Admission.
