**SPOT ALLOTMENT TO HOMOEOPATHY, AYURVEDA, SIDDHA, UNANI & ALLIED  
COURSES (AGRICULTURE, FORESTRY & FISHERIES)**

The vacant seats in Medical courses [Homoeo, Ayurveda, Siddha & Unani] and Allied Courses [Agriculture, Forestry & Fisheries] 2017 will be filled up through a Spot Allotment to be conducted by the Commissioner for Entrance Examinations at the Anatomy Hall inside Government Ayurveda College Campus, Thiruvananthapuram on 23<sup>rd</sup> October 2017 (Monday), 9.30 am. The Spot Allotment process, if not completed on 23.10.2017, shall be continued on 24.10.2017. The vacant Government seats in the Private Self Financing Ayurveda, Siddha and Unani colleges will be filled up in this Spot Allotment as per the directions in the Government letter dated 16.10.2017. The vacant seats in veterinary course will not be considered in this Spot Allotment due to the pendency of a Writ Petition in the Hon'ble High Court with regard to the seats in veterinary course.

**Online Registration for Spot Allotment**

Candidates who wish to participate in the Spot Allotment have to register online through the website of the Commissioner for Entrance Examinations [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) before 1 pm on 22.10.2017. Candidates can download 'Spot Allotment Slip' by logging into the link 'KEAM 2017-Candidate Portal' in the above website and by clicking the menu item 'Spot Allotment Registration'. Candidates are required to be present during the Spot Allotment along with the Spot Allotment Slip.


The Spot Allotment to be conducted in accordance with clause 11.6.9 of the Prospectus will be subject to the following conditions.

- i) Spot Allotment is conducted to fill up the vacant seats in each college.
- ii) Transfer between two Govt/Aided colleges or between two Self Financing colleges shall not be permitted for the same course.
- iii) Transfer between two different courses and transfer from a Self Financing college to Govt./Aided college and vice versa for the same course shall be allowed.
- iv) If a candidate already admitted in any of the above courses gets new allotment in Spot Allotment the seats that become vacant shall be filled up then and there itself.
- v) Candidates who have not been admitted to any of the courses shall have to produce transfer certificate and relevant documents to prove the eligibility for admission in original for the Spot Allotment.
- vi) Candidates seeking admission in the Government seats in the Private Self Financing Ayurveda, Siddha & Unani colleges shall have to produce all required documents including transfer certificate as the last date of admission to the Government seats in these colleges is 24.10.2017. The college authorities will be present in the Spot Allotment hall for the completion of the admission process.
- vii) Candidates who receive allotment to the Private Self-Financing Ayurveda, Siddha and Unani Colleges shall have to remit the fees as Demand Draft for Rs.75000/- drawn in favour of the Commissioner for Entrance Examinations payable at Thiruvananthapuram.
- viii) Candidates who figure in the Medical/Ayurveda rank list - 2017 prepared by the Commissioner for Entrance Examinations can participate in the spot allotment.
