As per the Government order read as 1<sup>st</sup> paper above, Government have approved the fee structure in the Self Financing Engineering Colleges under the consensual agreement with Kerala Catholic Engineering College Management Association (KCECMA) for the academic year 2017-18.

2. Commissioner for Entrance Examinations, as per the letter read as 2<sup>nd</sup> paper above, has informed that some Colleges under Kerala Catholic Engineering College Management Association (KCECMA) has requested to exempt the Interest free Refundable Deposit of Rs.1,00,000/- (Rupees One lakh only) while making allotment through Centralized Allotment Process (CAP) 2017.

3. Government have examined the matter in detail and are pleased to accept the exemption of Interest Free Refundable Deposit of Rs.1,00,000/- (Rupees One lakh only) while making allotment under Centralized Allotment Process (CAP) subject to the condition that this exemption has been already laid down under fee structure of individual colleges in the common prospectus issued in the name of Kerala Catholic Engineering College Management Association (KCECMA) by the signatory of the consensual agreement 2017.

4. The Commissioner for Entrance Examinations will make allotments only to the seats under Government quota, in Private Self financing Colleges.
