The admission to MBBS Course/BDS course in the aforesaid Self Financing Educational Institutions will be subject to the renewal permission granted by Medical Council of India/Dental Council of India, as the case may be for the academic session 2018-19.

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Clause (a) of sub section (1) of section 8 of the Kerala Medical Education (Regulation and Control of Admission to Private Medical Educational Institutions) Act, 2017 (15 of 2017) provides that the fee fixed by Admission and Fee Regulatory shall be valid for such period as may be notified by the Government. The Admission and Fee Regulatory Committee has regulated the fee applicable for admission to MBBS and BDS courses in Self Financing Medical Educational institutions for the academic year 2018-19. The Hon'ble High Court in its order dated 2-11-2017 in WP(C) No. 30032 of 2017 (D) and connected cases directed the State Government to notify the fee structure, seat matrix and other details to enable the students to choose a particular college to his/her liking. Hence this notification.

This notification is intended to achieve the above object.
