ORDER

In the Government order read as 1st paper above, Government have approved the Prospectus for admission to Three year LLB Course for the year 2012-13. As per the Government Order read as 2nd paper above, the last date for admission to the course was extended up to 31.10.2012,

2. The Commissioner for Entrance Examinations in the letter read as 3rd paper above, has informed that vacancies in Government seats in all Govt. Law Colleges and new Self Financing Law Colleges still exist, even after the final phase of allotment.

3. In the circumstances, after considering the request of the Commissioner for Entrance Examinations, Government are pleased to accord sanction to the Principals of Government Law Colleges and new Self Financing Law Colleges to fill up the existing vacancies in the Government Quota in their respective Colleges for the Three year LLB course for the year 2012-13 from the rank list and category list published by the Commissioner for Entrance Examinations by conducting Spot Admission on or before 31.10.2012. The Spot Admission shall be made by giving wide publicity through the newspapers and various mass media and by strictly observing merit and reservation principles as laid down in the Prospectus for admission to Three Year LLB course for the year 2012-13. No admission shall be made to the course after 31.10.2012, even if vacancies arise thereafter.

4. Government also order that the rank list prepared by the Commissioner for Entrance

Examinations for the Three year LLB Course for 2012-13 will have validity up to 31.10.2012.


