ORDER

As per the Government Order read as 1<sup>st</sup> above, Government have approved the Prospectus for admission to 3 year L.L.B course for the academic year 2012-13. Later on, in the Govt. order read as 2<sup>nd</sup> paper above, Government have extended the last date of allotment of candidates to 3 year LLB course to the Government Law Colleges and Self Financing Law Colleges up to 31/10/2012. In the Govt order read as 3<sup>rd</sup> above, permission was granted to all principals of Government & Self Financing Law colleges to conduct spot admission to the vacant seats in their respective colleges. However, several representations were received by Government informing that even after spot admission, many seats for the 1<sup>st</sup> year of 3 year LLB course are lying vacant in Government & Self Financing Law colleges.

Accordingly, Government have examined the matter with reference to the report of the Commissioner for Entrance Examinations & principals of Law colleges concerned and are pleased to accord sanction to the the Principals of Government Law Colleges and new Self financing Law Colleges to fill up the existing vacancies in the Government Quota in their respective Colleges for the 3 year LLB course for the year 2012-13 from the rank list and category list published by the Commissioner for Entrance Examinations by conducting Spot Admission again on or before 15.12.2012. The Spot Admission shall be made by giving wide publicity through the newspapers and various mass media and strictly observing merit and reservation principles as laid down in the Prospectus for admission to three Year LLB course for the year 2012-13. No admission shall be made to the course after 15.12.2012 even if vacancies arise thereafter.

Government also order that the rank list prepared by the Commissioner for Entrance Examinations for the 3 year LLB course for the academic year 2012-13 will have validity upto 15.12.2012. The prospectus approved as per the Govt. order read above also stands modified accordingly.
