ORDER

In the Government order read as first paper above, Government have approved the prospectus for admission to Integrated 5 year LLB Course; for the year 2011-12. As per the Government Order read as 2nd paper above, Government have amended the clause 12 (V) of the prospectus incorporating the condition that a general category candidate should get a minimum of 20% of the total marks in the Entrance Examination and a candidate belonging to Scheduled Caste and Scheduled Tribes category should get a minimum of 15 % of total marks for qualifying the Entrance Examination. Considering the circumstances reported by the Commissioner for Entrance Examinations, Thiruvananthapuram vide letter read as 3rd paper above Government have re examined the matter in detail and decided further to amend the clause 12 (V) at the prospectus and are pleased to order that clause 12 (V) of the said prospectus stands amended as detailed below:

" To qualify and thereby figure in the rank list for admission to Integrated Five Year LLB Course, a General Category candidate should get a minimum of 10% of the total marks in the Entrance Examination and a candidate belonging to Scheduled Caste/Scheduled Tribes Category should get a minimum of 5% of total marks where the total marks being 600 in the Entrance Examination".


