**ADMISSION TO INTEGRATED FIVE YEAR LL.B COURSE 2018**  
**SPOT ALLOTMENT FOR FILLING UP OF VACANT SEATS**

The second allotment for admission to the Integrated Five Year LL.B course in the Government and Self Financing Law colleges in the State was published on 21.09.2018 and the candidates were directed to join the allotted colleges before 5 pm on 25.09.2018. The vacant seats, if any, remaining after 25.09.2018, 5 pm shall be filled up through a Spot Allotment to be conducted by the Commissioner for Entrance Examinations at T.J.M Hall in the LMS compound, Palayam, Thiruvananthapuram on 27<sup>th</sup> of September 2018.

Candidates who have figured in the rank list of Integrated Five year LL.B course 2018 published by the Commissioner for Entrance Examinations and satisfying the eligibility as per clause 6 in the prospects can participate in the Spot Allotment.

**Online registration for Spot Allotment:**

Candidates who wish to participate in the Spot Allotment shall have to download the 'Spot Allotment Registration Slip' by clicking the link 'Spot Allotment Registration' available in their home. Candidates can enter their Application Number & Password in the link 'Integrated Five Year LL.B 2018 - Candidate Portal' provided in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) to log on to their home page. This 'Spot Allotment Registration Slip' should be produced at the venue of Spot allotment as per the following schedule.

Rank 1 to 2000	27.09.2018, 10 am
Rank 2001 and above	27.09.2018, 2 pm

**Guidelines for Spot Allotment**

- (i) In the Spot allotment, transfer will not be permitted to students already admitted to any course in a Government Law College to the same course in another Government Law College. But course change will be permitted to another Government Law college.
- (ii) In the Spot allotment, transfer will not be permitted to students already admitted to any course in a Self Financing Law College to the same course in another Self Financing Law College. But course change will be permitted between the Self Financing Law colleges or within the same Self Financing Law college.
- (iii) In the Spot allotment, transfer will be permitted to students admitted in Self Financing Law colleges to Government Law colleges and vice-versa.

Candidates who get allotment in the Spot allotment shall have to join the allotted colleges before 29.09.2018, 5 pm along with the original documents mentioned in clause 18 of the Prospectus for admission to Integrated Five Year LL.B course 2018. The annual tuition fee, deposit (if applicable) and other fees as per the Government order published in the website of the Commissioner for Entrance Examinations should be remitted in the allotted colleges at the time of admission.
