**ADMISSION TO INTEGRATED FIVE YEAR LL.B COURSE-2019**  
**SPOT ALLOTMENT FOR FILLING UP OF VACANT SEATS**

A Spot Allotment for filling up the vacant seats existing under Integrated Five Year LL.B course in the Government and Self Financing Law colleges in the State and the 50% seats in BA LL.B course in the Private Self Financing Law College viz; *Guru Nithyachaithanya Yathi College of Law and Research Centre, Kareelakulangara, Kayamkulam* shall be conducted by the Commissioner for Entrance Examinations **on 14.08.2019 (Wednesday) at L.M.S Women's Centre Conference Hall in the LMS compound, Palayam, Thiruvananthapuram** as per the following schedule.

Candidates having Rank 2001 and above	14.08.2019, 2 pm

Candidates who have figured in the rank list of Integrated Five Year LL.B course-2019 published by the Commissioner for Entrance Examinations and satisfying the eligibility criteria as per clause 6 in the Prospectus can participate in the Spot Allotment. The details of vacant seats in the Integrated Five Year LL.B course in the various Law colleges will be made available in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

**Online registration for Spot Allotment is mandatory:**

Candidates who wish to participate in the Spot Allotment shall have to log on to their home page provided in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) by giving their Application Number & Password through the link '**Integrated Five Year LL.B 2019 - Candidate Portal**' and should download the '**Spot Allotment Registration Slip**' by clicking the link '**Spot Allotment Registration**' which will be made available in their home page from **09.08.2019 to 13.08.2019, 5 pm**. **Candidates should be present in the venue of the Spot allotment on the respective date and time with this 'Spot Allotment Registration Slip'.**

**Conditions for Spot Allotment**

- (i) In the Spot Allotment, transfer will not be permitted to students already admitted to a course in a Government Law College to the same course in another Government Law College. But course change will be permitted between two Government Law colleges.
- (ii) In the Spot allotment, transfer will not be permitted to students already admitted to a course in a Self Financing Law College to the same course in another Self Financing Law College. But course change will be permitted between two Self Financing Law colleges or within the same Self Financing Law College.
- (iii) In the Spot allotment, transfer will be permitted to students admitted in Self Financing Law colleges to Government Law colleges and vice-versa for any course.

Candidates who get allotment in the Spot allotment shall have to join the allotted colleges before **20.08.2019, 4 pm** along with the original documents mentioned in clause 18 of the Prospectus for admission to Integrated Five Year LL.B course-2019, after remitting the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any selected Head Post Office. The balance tuition fee, deposit (if applicable) and other fees as per the Government orders published in the website of the Commissioner for Entrance Examinations should be remitted in the allotted colleges at the time of admission.

**Note:** The vacancies, if any, remaining in Integrated Five Year LL.B course in Government/Self Financing Law colleges after 5 pm on 20.08.2019 shall be filled up through Spot Admission to be conducted by the college Principals concerned before 31.08.2019, 5 pm.
