ADMISSION TO LL.M COURSE, 2015-16
SECOND PHASE OF ALLOTMENT PUBLISHED

The second and final phase of Centralised Allotment for admission to LL.M Courses in Government Law Colleges and Private Self Financing Law Colleges in the State for the year 2015-16 is published herewith on the website www.cee.kerala.gov.in.

Candidates shall have to click '[LL.M 2015-Candidate Portal](#)' available in the website www.cee.kerala.gov.in. After that the candidates have to enter their Application Number and Roll Number in order to access their home page. Then by clicking the menu item '**Allotment Result**' and by submitting their key number and password, candidates can download their Allotment Memo. The details such as candidate's name, roll number, allotted college, Allotment category, tuition fees to be paid etc. are available in the allotment memo. The candidate shall take a printout of the allotment memo and produce it before the College Authorities at the time of admission.

Candidates who receive allotment afresh and those candidates who get a change in allotment than that of the first allotment should report for admission to the Principal of the allotted colleges as per the second phase allotment memo on any date from **21.03.2016** to **23.03.2016**, along with the second phase allotment memo and original documents specified in Clause 17 of the Prospectus. They should remit the fee as shown in the Allotment memo in the allotted college at the time of admission. All the college authorities should approve and submit the list of admitted candidates through the link '[Approval of Admission list of Candidates](#)' in the home page of the Online Admission Management System (OAMS) at **5.30 p.m. on 23.03.2016**.

The candidates who do not join the College with in the stipulated time will lose their present allotment.

The vacant seats, if any, in Govt./Self Financing Law Colleges still remaining after 5 pm on 23.03.2016 shall be filled by the College Authorities concerned through Spot Admission on or before **31.03.2016**. The College authorities are authorized to conduct Spot Admission on or before 31.03.2016 in accordance with the conditions stipulated in Clause 16.7(b) of the Prospectus for LL.M Course 2015-16 after giving wide publicity regarding the same through print and visual media. The vacant seats, if any, in Self Financing Law Colleges after 23.03.2016 shall be filled as Government Merit seats through Spot Admission.
