B.Sc.NURSING AND PARAMEDICAL DEGREE COURSES - 2017
THIRD PHASE OF CENTRALISED ALLOTMENT PUBLISHED

The third phase of allotment to B.Sc. Nursing course and Paramedical Degree courses such as B.Sc. (M.L.T), B.Sc. Perfusion Technology, B.Sc.(Optometry), B.P.T, B.A.S.L.P, B.C.V.T, B.Sc. MRT, B.Sc. Medical Biochemistry and B.Sc. Medical Microbiology Courses-2017 is published herewith on the website www.cee.kerala.gov.in. The allotment is based on the online options received upto 13.09.2017, 1 pm by the candidates included in various rank lists for B.Sc Nursing and Paramedical Degree Courses prepared and published by the Commissioner for Entrance Examinations. **This is the last phase of allotment to Self Financing Nursing and Paramedical Colleges.**

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the third phase allotment memo which shows the details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc.

Those candidates who receive an allotment afresh have to remit the fee to be paid to the Commissioner for Entrance Examinations as specified in the third phase allotment memo at any of the designated branches of **State Bank of India** or by way of **Online Payment** on **14.09.2017** or **15.09.2017** and should join the colleges allotted before **5pm** on **15.09.2017**. The list of designated branches of **SBI** is available on the website. Candidates who get a change in allotment than that of the previous one need only join the allotted college before **5 pm** on **15.09.2017**.

Candidates who do not remit the fee and join the college allotted, before 5pm on 15.09.2017 will lose their allotment as well as the existing higher options in the stream (Nursing stream/Paramedical stream) to which the allotment belongs. The options once lost will not be available in the subsequent phases.

Note: This Allotment is the last phase of allotment to Self Financing Nursing and Paramedical colleges. Hence, students who get allotment in Self Financing Nursing and Paramedical colleges in the third phase should invariably join the colleges allotted, before 5 pm on 15.09.2017 and should continue their studies in the college allotted. Otherwise they are liable to pay the Liquidated Damages as per clause 13 (a) of the Prospectus for B.Sc. Nursing and Paramedical Degree Courses-2017. Also such candidates will not be eligible for the refund of fees, if any, paid to the Commissioner for Entrance Examinations, as per Clause 12.7.

The allotment to the Service Quota seats shall be done as and when the respective rank list for service candidates is made available to this office by the authorities concerned.

The allotment to the BCVT and B.Sc Perfusion Technology courses in MIMS College of Allied Health sciences, MIMS Academy, Vazhayoor, Puthukode.P.O. Malappuram is provisional and subject to the final orders of the Hon'ble High Court of Kerala on IA No. 9780/2017 IN WP(C) No. 37007/2016(A). The fee for the courses will be as fixed by the Government/Admission and Fee Regulatory Committee.

All the college authorities should approve and submit the list of admitted candidates to Commissioner for Entrance Examinations through Online Admission Management System (OAMS) before 5.30 pm on 15.09.2017.
