**B.Sc.NURSING AND PARAMEDICAL DEGREE COURSES - 2017**

**SECOND PHASE OF CENTRALISED ALLOTMENT PUBLISHED**

The second phase of allotment to B.Sc. Nursing course and Paramedical Degree courses such as B.Sc. (M.L.T), B.Sc. Perfusion Technology, B.Sc.(Optometry), B.P.T, B.A.S.L.P, B.C.V.T, B.Sc. MRT, B.Sc. Medical Biochemistry and B.Sc. Medical Microbiology Courses-2017 is published herewith on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment is based on the online options filed upto 25.08.2017, 3 pm by the candidates included in various rank lists for B.Sc Nursing and Paramedical Degree Courses prepared and published by the Commissioner for Entrance Examinations.

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the second phase allotment memo which shows the details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. Those candidates who receive an allotment shall have to remit the fee/balance to be paid to the Commissioner for Entrance Examinations as specified in the first phase allotment memo at any of the designated branches of State Bank of India or by way of Online Payment from 26.08.2017 to 31.08.2017, 3 pm and should join the colleges allotted before 31.08.2017, 5 pm. The list of designated branches of SBI is available on the website.

In this phase, allotment is done to Sports Quota, NCC Quota and the seats reserved for Persons with Disability (PD). Also allotment is done to the Minority Quota seats in Private Self Financing Nursing & Paramedical Colleges having minority status in this phase.

Those candidates who do not remit the fee and join the college allotted on or before the date prescribed for the same will lose their allotment as well as all the existing options in the stream (Nursing stream/Paramedical stream) to which the allotment belongs. The options once lost will not be available in the subsequent phases.

**Token Deposit:** Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have to remit Rs.1000/- through any of the methods above and should join the college allotted before 5pm on 31.08.2017.

Allotment has not been done to the Service Quota seats in this phase. The allotment to the Service Quota seats shall be done as and when the respective rank list for service candidates is made available to this office by the authorities concerned.

The allotment to the BCVT and B.Sc Perfusion Technology courses in MIMS College of Allied Health sciences, MIMS Academy, Vazhayoor, Puthukode.P.O. Malappuram is provisional and subject to the final orders of the Hon'ble High Court of Kerala on IA No. 9780/2017 IN WP(C) No. 37007/2016(A). The fee for the courses will be as fixed by the Government/Admission and Fee Regulatory Committee.

All the college authorities should approve and submit the list of admitted candidates to Commissioner for Entrance Examinations through Online Admission Management System (OAMS) before 5.30 pm on 31.08.2017.
