

Instructions for submitting the Application for PG Ayurveda Courses-2012

All candidates seeking admission to the PG Ayurveda Courses-2012 should paste a photograph (same as the one uploaded) in the space provided in the printout of the online application and sign over it with half the signature over the photograph and half outside. The 'Declaration' in page 2 of the application also must be signed by the candidate.

Candidates must submit the following documents along with the Application.

1. Any of the following documents to prove **Nativity**.

(i) For Keralites :-

(a) Self attested copy of SSLC / Birth Certificate / Passport of candidate or either of the parents showing the candidate's or either of the parent's **place of birth in Kerala**. In case certificate of parent is attached, corroborative certificate to establish the relationship between the parent and the candidate should also be attached.

OR

(b) Certificate of Birth (**I. [a]** in the Application form) from the village officer / competent revenue authority stating that the candidate or his/her father/mother was born in Kerala.

(ii) For candidates outside Kerala State:-

Certificate of Residence (**II[b]** in the Application form) from the competent revenue authority

2. Document to prove **Age**.

3. Certificates to prove **Academic Qualifications**.

(a) Self attested copy of BAMS Degree certificate/Pass certificate.

(b) Self attested Copy of Mark list of each BAMS examination.

(c) Self attested copy of Internship Certificate as per clause 4(a) of the prospectus.

4. **SEBC candidates** should produce Community and Income (below 4.5 lakhs) Certificates /Intercaste marriage certificate (if claimed)from the village officer concerned in the proforma available with the printout of the application form. *[Make sure that the certificates bear the Signature & Name of village office/Thaluk Office, designation seal and office seal]*

5. **SC / ST candidates** should produce Community Certificate from the Tahsildar concerned in the proforma available with the application form. Candidates claiming reservation under SC/ST through intercast marriage certificate should also produce Community Certificate from the Tahsildar concerned in the proforma available with the application form

6. Fee receipt /DD of the amount paid in bank, **in original**.

(a) Fee for General candidates: **1000/-**

(b) Fee for SC / ST candidates: **500/-**

(c) Fee for Service candidates: **1000/-**

(d) Service candidates applying also under General Quota should remit both the fees as applicable.

(e) Declaration regarding Service Quota benefit for PG Ayurveda availed previously (For service Quota candidates only)

All the candidates (**Except Service Quota candidates**) should forward the printout of the Application form along with supporting documents to the **Commissioner for Entrance Examinations, Vth floor, Housing Board Buildings, Santhi Nagar, Thiruvananthapuram- 695 001** before the last date notified.

The Service candidates should forward the Applications along with required documents to the **Directorate of Ayurveda Medical Education, Thiruvananthapuram**.

Incomplete / defective / belated Applications will be rejected summarily.
