(MD Ayurveda)Courses-2013
Revised Ranklist Published

The Revised Provisional Rank list of General candidates who have appeared for the Entrance Examination for admission to MD Ayurveda 2013 conducted on 25.08.2013 at Thiruvananthapuram is published herewith as per the Interim Order of the Hon'ble High Court of Kerala in W.P.(C) Nos.25074,25185&25481 of 2013 dated 23.10.2013 .

The Provisional Rank list of General candidates who have appeared for the Entrance Examination for admission to MD Ayurveda 2013 was published vide notification No.2095/MDA/2013/TA4 /CEE dated 25.09.2013. As per the Interim Order of the Hon'ble High Court of Kerala in W.P.(C) Nos.25074,25185 & 25481 of 2013 dated 23.10.2013,the following answer key changes have been effected in the revised rank list.

In Paper I, Question Numbers 43, 44, 124 and 140 are deleted and key of Qn.No. 8 changed as D, Qn.No.20 changed as B, Qn.No.47 changed as A ,Qn.No.48 changed as D, Qn.No. 49 changed as B, Qn.No.80 changed as B, Qn.No.93 changed as B, Qn.No.111 changed as D and Qn.No.121changed as C and Qn.No.145 changed as B, Qn.No.146 changed as D and Qn.No.149 changed as B. Also in Paper II, key of Qn.No.59 changed as C, Qn.No.112 changed as A Qn.No.113 changed as A and Qn.No.145 changed as B.

While preparing the rank list, twelve questions in Paper I and nine questions in Paper II have been deleted, since there were more than one correct choices or errors in these questions/choices. These questions have not been included for valuation and no marks have been awarded for these deleted questions to any candidate. The marks obtained for the remaining 138 questions in Paper I have been multiplied by (150/138) and the marks obtained for the remaining 141 questions in Paper II have been multiplied by (150/141) to get the actual marks (corrected to four decimals). The above formula is applied to award proportionate marks based on the score of the candidates in the questions considered for valuation (excluding deleted questions) to compensate the loss of marks for the deleted questions.

The Revised Provisional Rank list of General Quota candidates will be available for reference in this office and on the website www.cee-kerala.org.

Inclusion of a candidate in the rank list does not entitle him/her for admission to the courses, unless he/she satisfies the eligibility conditions contained in the Government approved Prospectus. The Director of Ayurveda Medical Education will make allotment and admissions as per the conditions laid down in the Prospectus.
