### ORDER

Government as per the order read as 1<sup>st</sup> paper above have approved the prospectus for Admission to Post Graduate Dental Course (MDS) 2014. The Commissioner for Entrance Examination as per his letter dated 03.06.2014 has requested the Government to entrust the Director of Medical Education for conducting further allotment process for the P.G. Dental seats 2014 since that office is over burden with allotment process related to Engineering and Medical Professional courses. Government as per the letter read as the 3<sup>rd</sup> paper above had rejected the request.

The Commissioner for Entrance Examinations has again informed the Government that as per the judgment of the Hon'ble Supreme Court of India the 3<sup>rd</sup> round of counseling to the PG Dental seats has to be conducted before 25<sup>th</sup> June 2014. The allotment to Engineering and Medical professional courses have to be done simultaneously. The present staff strength of the Office of the Commissioner for Entrance Examinations is inadequate to handle this huge volume of work. Therefore the Commissioner for Entrance Examinations has requested Government to entrust Director of Medical Education for conducting further allotment for PG Dental courses 2014 as that office has to conduct counseling for allotment to P.G. Medical courses and to Engineering and Medical Courses from 20.06.2014 to 25.06.2014.

Government have considered the request of the Commissioner for Entrance Examinations and are pleased to authorize Director of Medical Education, Thiruvananthapuram for making further allotment to the vacant seats of P.G. Dental Course (MDS) 2014.

The Commissioner for Entrance Examination will furnish the list of vacant seats and other details to Director of Medical Education for compliance. The Commissioner for Entrance Examination will also give necessary publicity in this regard through print and visual media.
