**SECOND ROUND OF COUNSELING FOR ALLOTMENT AND ADMISSION TO
POST GRADUATE DENTAL (MDS) COURSES, KERALA -2014**

The Second round of counseling for the allotment process of the PG Dental (MDS) Courses 2014 for the 12 vacant seats in Government Dental Colleges at Thiruvananthapuram, Kottayam and Kozhikode after the first round of counseling is scheduled to be held on 03.05.2014 (Saturday) at the Office of the Commissioner for Entrance Examinations, Housing Board Buildings, Santhi Nagar, Thiruvananthapuram. The availability of seats in the Government Dental Colleges and the Fee Structure are available on the website www.cee-kerala.org

Candidates wishing to attend the second round of counseling will have to download their Admit Card which will be made available on the website www.cee.kerala.gov.in before Counseling. Candidates are required to fill in College and Course, which they would like to opt, in the "Preference Form" provided at the time of counseling. The Candidates who were not participated in the first round of counseling/not joined in the allotted Dental College within the stipulated time/relieved after joining the allotted Dental Colleges during the first round of counseling conducted on 05.04.2014 are not eligible to appear for the second round of counseling.

Selection and allotment will be strictly on the basis of Merit and Category as per the Kerala State Merit list and Revised Category List for admission to PG Dental Courses 2014 published by the Commissioner for Entrance Examinations, Kerala available on the website www.cee-kerala.org on the basis of available seats.

If a candidate is not able to attend the Second round of counseling for the allotment process on genuine grounds, the parent/guardian, or any authorized person can act as proxy at the risk of the candidate. Such authorized person should produce an authorization letter duly attested by a Gazetted Officer in the format which is available on the website www.cee-kerala.org. Those who have already furnished the authorization letter during the first round of counseling need to submit only the photo copy of the authorization letter with the office seal of the Office of Commissioner for Entrance Examinations. Candidate/proxy has to produce the admit card issued by the Commissioner for Entrance Examinations, Kerala and submit the original certificates and other documents mentioned in it for verification. The candidates unable to attend the Counseling as per the schedule noted below, will not be permitted to attend for further allotments in Government Dental Colleges.

Candidates allotted to Courses should remit the fee in the College concerned as prescribed and take admission in the College allotted as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission will lose their allotment as well as the claims for further allotments, if any. No extension of time for reporting to the College will be granted under any circumstances. The candidates are liable to pay admission fees as prescribed by the University concerned at the time of admission.
