ORDER

The admission to Post Graduate Dental Degree (MDS) Courses in the State during the academic year 2014-15 was done on the basis of the All India Post Graduate Dental Entrance Examinations 2014 (AIPGDEE-2014) by All India Institute of Medical Sciences.

2. As per the Government Order read as 2nd paper above, Government have ordered that admission to Post Graduate Medical Degree/Diploma (MD/MS) courses in the Medical Colleges/Institutions in the State for the academic year 2015-16 will be on the basis of the Common Entrance Examination (PG Medical entrance Examination 2015) conducted by the Commissioner for Entrance Examinations (CEE), Government of Kerala.

3. In furtherance to this order, Government are pleased to issue the following orders.

- The admission to Post Graduate Dental Degree (MDS) course in the Dental Colleges/Institutions in the State for the academic year 2015-16 will be on the basis of the Common Entrance Examination (PG Dental Entrance Examination 2015) conducted by the Commissioner for Entrance Examinations (CEE), Government of Kerala. The PG Dental aspirant

candidates from the State shall participate in PG Dental Entrance Examination 2015 conducted by the CEE and obtain minimum eligibility marks as prescribed, for getting admission to Post Graduate Dental (MDS) Course for the academic year 2015-16.

- The Prospectus for admission to Post Graduate Dental (MDS) course will be issued by the Director of Medical Education with the approval of the Government. The Commissioner for Entrance Examinations will be the authority for conducting the admission and allotment in the State Quota seats in MDS course for the year 2015-16., observing the prevailing reservation principles for admissions.
- The Commissioner for Entrance Examinations will give wide publicity regarding the schedule of application/examination of PG Dental Entrance Examination 2015 along with necessary instructions to the Post Graduate Dental aspirant candidates, through the Official Website, Print and Visual Media.


