## ALLOTMENT TO P G DENTAL COURSES, KERALA-2016 SCHEDULE FOR FIRST PHASE OF ALLOTMENT

The activities related to the first phase of centralized allotment to Post Graduate Dental Courses for the year 2016 will commence from **04.04.2016 (Monday)**.

The General & Service Quota candidates included in the Rank lists published by the Commissioner for Entrance Examinations can register their options on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from **04.04.2016 to 10.04.2016, 3 pm.**, after downloading their Key Number.

Candidate shall have to click 'MDS 2016-Candidate Portal' available in the above website. After that the candidates have to enter their Application Number and Roll Number in order to access their home page. They can download their key number after clicking the menu button 'Print Key Number' by entering their password. Candidates can download their key number from **04.04.2016 to 10.04.2016, 3 pm** and must keep their key number safely for further use.

The Candidates can register their options online by clicking the menu item 'Option Registration' available in the home page and then by submitting their key number and password.

Results of the Entrance Examination of some of the candidates have been withheld due to the defects in their applications. Such candidates can also register their options online. But they will not be considered for allotment unless they produce the required documents to correct the defects in their applications in the office of the Commissioner for Entrance Examinations before **3 pm on 09.04.2016**.

<b>15.04.2016 to 22.04.2016, 5 pm</b>	All candidates should join the course and college to which they are allotted along with the required documents and Fee Receipt.
<b>22.04.2016, 5.30 pm</b>	Principals of Colleges to submit non-joining report through Online Admission Management System ( <b>OAMS</b> ) to the office of CEE

The list of Dental Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment is provided in the Home page of the candidate. Candidates can give options as per their priority of the Course-College combinations in the option list. **A candidate need only give options to a Course-College combination if he/she is sure to join the course and college, if allotted.** Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed /considered for allotment to the courses.

Candidates allotted to courses, and who remit the fee as prescribed, should take admission in the college allotted as per the schedule prescribed by the CEE. Candidates who do not remit the prescribed fees/take admission will lose their allotment as well as the claims for further online allotments, if any. No extension of time for reporting to the college will be granted under any circumstances. The candidates are liable to pay admission fee as prescribed by the University concerned at the time of admission.
