**SECOND PHASE OF ALLOTMENT TO PG Dental (MDS) Courses 2016**

The activities related to the second phase of Single Window System of allotment to Post Graduate Dental (MDS) Courses for the year 2016 will commence from 11.05.2016 (Wednesday).

Candidates who have already submitted online options and who want to participate in this phase of allotment must compulsorily confirm their online options by clicking the 'confirm' button available on his/her home page. After option confirmation such candidates can delete the unwanted higher options and can re-arrange their existing higher options. In addition all the eligible candidates can register fresh options to the newly included Private Self Financing Dental colleges and the newly sanctioned courses at Govt. Dental College Kottayam. The facility for online option confirmation /deletion/re-arrangement/registration of fresh options will be available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from 11.05.2016 to 14.05.2016, 3 pm. Those who do not confirm their options online within the stipulated time will not be considered for allotment in this phase.

The seat matrices of Private Self Financing Dental Colleges, newly sanctioned five seats at Government Dental College, Kottayam and the fee structure approved by the Government are also available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

**The schedule for the second phase of allotment is given below:**

11.05.2016	Website opens for enabling online option confirmation/re-arrangement / deletion of existing options and for filing fresh options to newly included colleges and courses
14.05.2016 - 3 pm	Facility for option confirmation/ registration /re-arrangement / deletion of options ends.
17.05.2016	Publication of second phase of allotment
18.05.2016 to 27.05.2016	All candidates who get an allotment shall remit the fee / balance fee as shown in the allotment memo at selected branches of State Bank of Travancore (SBT).
18.05.2016 to 27.05.2016, 5 pm	All candidates should join the course and college to which they are allotted along with the required documents and Fee Receipt.
27.05.2016	Principals of Colleges to submit non-joining report through Online Admission Management System (OAMS) to the office of CEE

Candidates allotted to the courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission will lose their allotment as well as the claims for further online allotments, if any.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.
