ORDER

Sanction was accorded to start Post Graduate course in Dental Sciences (MDS) in Mar Basalios Dental College, Kothamangalam vide Government Order read as first paper above and the College has entered in to an agreement regarding sharing of 50% seats with Government and to be filled up that seat from the list prepared by the Commissioner for Entrance Examination.

As per the Government Order read as second paper above, Government have issued prospectus for admission to Dental Post Graduate Courses 2010. But due to the non availability of continuance sanction from Dental Council of India /Government of India at the time of the preparation of the Prospectus, the 50% seats for MDS course available in Mar Basalios Dental College, Kothamangalam has not been included in the prospectus

As per the letter read as third paper above, the Director of Medical Education has reported that now the course has obtained continuance sanction and hence requested Government to include 50% of the seat in Dental Post Graduate Course available in Mar Basalios Dental College, Kothamangalam in the prospectus for admission to MDS course 2010 in order to allot the eligible candidates from the list prepared by the Commissioner for Entrance Examination.

Government have examined the proposal in detail and are pleased to include 50% of MDS seats available in Mar Basalios Dental College, Kothamangalam in the Prospectus for Dental Post Graduate Course 2010 as done in last year. The Director of Medical Education will take further action accordingly.

The Prospectus for Dental Post Graduate Course 2010 is modified to the above extent.
