ORDER

As per the Government Order read as 5th paper above, Government have issued orders to conduct online counseling so as to fill up the vacancies in the State and the additional seats vacant consequent to allotment for the fourth round of All India Quota seats counseling. As per the letter read as 6th paper above, the Director of Medical Education has reported that the Hon'ble Suprème Court of India has allowed the State of Maharastra and Gujarat to conduct counseling for left over seats for the All India Quota and the admission shall be closed by 31st August 2013. The Director of Medical Education has reported that the order is applicable to other states also and furnished a proposal for the last and final counseling for the unfilled Government Quota seats, State quota seats which became vacant consequent to the fourth round of All India Counseling and Surrendered All India Quota seats.

- 2. Government have examined the case in detail and are pleased to issue the following orders for the last and final round of counseling to Post Graduate Medical Degree/Diploma Courses 2013.
- (i) The Commissioner for Entrance Examinations is authorized to conduct a last and final online/Manual counseling as the case may be, on 29th and 30th August

2013 for filling up of the unfilled Government Quota seats, State quota seats which became vacant consequent to the fourth round of All India Counseling and Surrendered All India Quota seats in Government/Self financing Medical Colleges.

- (ii) The candidates who have already taken admission under All India Quota and holding All India Quota seat at present are not allowed to attend the counseling.
- (iii) The Director of Medical Education will furnish the details of the vacant seats to the Commissioner for Entrance Examinations on or before 27th August 2013.
- (iv) The Self Financing Medical Colleges will furnish the details of Vacant Government merit quota seats in the institutions to the Commissioner for Entrance Examinations so that the seats can be filled through the Counseling.
- (v) The candidates coming from the Self Financing Medical Colleges to attend the counseling shall produce all their original certificates, NOC and necessary affidavits stating that the Self Financing Medical College Management is willing to admit candidates from the Government Merit list in the resultant vacancies.
- (vi) The candidates who are allotted a subject in the counseling and do not join the course on any reason shall be liable to pay the liquidated damages as per the conditions in the Prospectus.
- (vii) No candidates who have already admitted in Government Medical Colleges are allowed to move to another Government Medical College in the same subject.
- (viii) No transfer from one Self Financing Medical College to another shall be allowed.
