ORDER

Government have discussed the matter of allotment of seats to Post Graduate Medical (MD/MS/Diploma) courses in Self Financing Medical Colleges and fees to be levied in the Private Self Financing Medical Colleges. A consensus regarding the fee structure for PG Medical Courses for the academic year 2014-15 was arrived at and an agreement has been executed with them for the admissions during 2014-2015.

In the circumstances, orders are issued regarding allocation of merit seats in the following Self Financing Medical Colleges and sanction is accorded to the Commissioner for Entrance Examinations for including the colleges for allotment of students for admission to Post Graduate Medical (MD/MS/diploma) Courses for the academic year 2014-2015, subject to the terms and conditions specified below.

1. Sree Gokulam Medical College & Research Foundation, Venjaramoodu, Thiruvananthapuram
2. Dr.Somervell Memorial CSI Medical College, Karakonam, Thiruvananthapuram
3. MES Medical College, Perinthalmanna, Malappuram

Terms and Conditions: -

1. 50% of total PG Medical (MD/MS/Diploma)seats sanctioned in the college will be filled up by the Government from the list prepared by the Commissioner of Entrance Examinations in accordance with merit and reservation principles followed by Government from time to time.
2. The Government shall furnish the list of the students to be admitted in the college by the educational agency and the educational agency concerned shall admit the students specified in the list. The students in the list will be given specific instructions as to the date and time of presentation before the college for admission, the amount of fees to be paid, and the records to be submitted at the time of admission. The educational agency shall admit the students who have complied with the instructions as certified by the Government. The Government shall furnish such list on or before 30th June 2014 or such other date as mutually agreed upon by the parties. The Managements concerned shall accept and admit the students accordingly following the above procedures but in any case not later than 5 PM on 30th June 2014. The Management concerned shall be entitled to fill those seats remaining unfilled by Government after the cut off date for admission to the seats to be filled by the Government for the academic year 2014-15, subject to the condition that the forfeited seats will not be compensated during next academic year.
3. If any student is not admitted by the educational agency concerned for specific defects or for reasons what so ever, it shall intimate the Government the defects or reasons as the case may be and the Government shall rectify the defects or state the reasons for accepting the list or furnish a revised list which the management concerned shall accept and admit the students accordingly following the above procedures.
4. The educational agency concerned agrees to collect annual tuition fees for those 50% merit quota students during the entire course period at the rate specified below.

Post Graduate Degree (Clinical)	- ₹ 6,50,000/-
Post Graduate Degree (Non-Clinical)	- ₹ 2,60,000/-
Post Graduate Diploma (Clinical)	- ₹ 4,90,000/-

Signed and sealed receipts shall be given by the management/college for all students.

5. The annual tuition fee fixed shall be inclusive of all amounts collected as in the case of similarly situated students in Self Financing Colleges. However, the educational agency concerned can also collect the proportionate share of fee payable to the University and other bodies in relation to the course of study being undergone by each student. The educational agency concerned shall not collect any amount from any student so admitted, other than those specified above.
6. 50% of the total seats shall be Management quota seats (except NRI quota) to be filled by the educational agency on the basis of merit from the list of students who have qualified themselves in All India Post Graduate Medical Entrance Examination 2014 (AIPGMEE - 2014). In the event of sufficient number of qualified candidates under AIPGMEE-2014, who have applied for Management Quota seats in the institution concerned are not available, the Managements can admit students on the basis of any P.G Medical Entrance Examination 2014 conducted at the National Level as per MCI norms. Out of the 50%, the Managements are entitled to fill up 15% of seats by the eligible students who are children/dependants of Non- Resident Indians, as per the conditions stipulated in GO(MS)No.34/2013/H&FWD dated 05.02.2013 and further orders in this regard if any, issued by Government from time to time. However the rotation of NRI seats shall be restricted to the following specialities, viz, General Medicine, General Surgery, Paediatrics, Radiodiagnosis, Dermatology & Venereology, TB & Chest Diseases, Orthopaedics and Obstetrics & Gynaecology. The seats reserved for NRI candidates and the fee for NRI Quota shall be notified in the respective Prospectus by the Colleges/Association. All the Students under NRI Quota are exempted from qualifying in any Entrance Test and can be admitted based on their academic eligibility as stipulated by the University.
7. In view of the representation of the educational agency with regard to the expenses incurred for establishing and administering and for further developing infrastructure and facilities in the college, the educational agency shall be entitled to collect annual fee for the 50% management quota students during the entire course period at the rate specified below.

Post Graduate Degree (Clinical)	- ₹ 14,50,000/-
Post Graduate Degree (Non-Clinical)	- ₹ 6,00,000/-
Post Graduate Diploma (Clinical)	- ₹ 11,00,000/-

The students under 50% Management Quota including NRI Quota, will have to submit a bank guarantee at the time of admission for the annual tuition fee for the entire course period

8. The seat sharing between the Educational agency and Government shall be as per the methodology fixed as per GO(Rt)No.2138/2011/H&FWD dated 02.06.2011.


9. The educational agency undertakes that no consideration in cash or kind other than those specified above shall be received, accepted or collected in any form whatsoever from any student admitted to college. It shall be the liability of the educational agency to redress complaints from the students, parents or interested parties on any matter other than those covered by the terms and conditions of the agreement.
10. This Agreement is valid for the Academic Year 2014-2015 only and shall not prejudicially affect the rights of the parties by virtue of the clauses herein, in respect of the cases pending before any Court of Law.
11. The chart for distribution of seats in the Self Financing Medical colleges in the Colleges mentioned above, prepared by the Director of Medical Education based on the stipulations specified as per GO(Rt)No.2138/2011/H&FWD dated 02.06.2011 and forwarded vide letter read as 1st paper above is approved herewith and annexured to this order.
