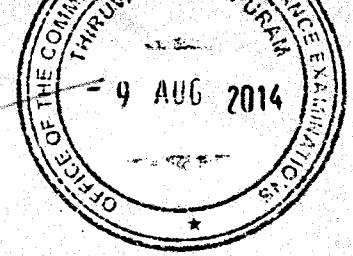

ORDER

The admission to Post Graduate Medical Degree/ Diploma Courses in the State during the academic year 2014-15 was done on the basis of the All India Post Graduate Medical Entrance Examinations 2014 (AIPGMEE-2014) conducted by the National Board of Examinations (NBE).

2. As per the letter read as 2nd paper above, the National Board of Examinations (NBE) has requested to inform whether the State Government is willing to join AIPGMEE 2015 for admission to Post Graduate Medical courses in the State for the academic year 2015-16.

3. Government have examined the matter in detail and are pleased to issue the following orders.

- The admission to Post Graduate Medical Degree/Diploma (MD/MS) courses in the Medical Colleges/Institutions in the State for the academic year 2015-16 will be on the basis of the Common Entrance Examination (PG Medical Entrance Examination 2015) conducted by the Commissioner for Entrance Examinations (CEE), Government of Kerala. The PG Medical aspirant candidates from the State shall participate in PG Medical Entrance Examination 2015 conducted by the CEE and obtain minimum eligibility

marks as prescribed, for getting admission to Post Graduate Medical Courses for the academic year 2015-16.

- The Prospectus for admission to Post Graduate Medical courses will be issued by the Director of Medical Education with the approval of the Government. The Commissioner for Entrance Examinations will be the authority for conducting the admission and allotment in the State Quota seats in P.G. Degree / Diploma courses for the year 2015-16., observing the prevailing reservation principles for admissions.
- The Commissioner for Entrance Examinations will give wide publicity regarding the schedule of application/examination of PG Medical Entrance Examination 2015 along with necessary instructions to the Post Graduate Medical aspirant candidates, through the Official Website, Print and Visual Media.
