ORDER

Government as per the Order read as first paper above approved the Prospectus for admission to Post Graduate Medical Courses for the academic year 2015-16. Accordingly, the Commissioner for Entrance Examinations, in accordance with the time limit stipulated by the Hon'ble Supreme Court of India and in line with the Government Orders issued in this regard, completed two rounds of counseling. Now, the Commissioner for Entrance Examinations as per the letter read above has informed Government that the third round of counseling (manual) to fill up the vacant MD/MS State Quota Seats and seats expected to be reverted from All India Quota, is scheduled on 01.06.2015 and further requested to modify the Clause 11.1.1 of the Prospectus so as to enable the candidates included in the Rank list/ Category list published by the Commissioner for Entrance Examinations, except those who have already joined under the All India Quota and still holding the seat to participate in the third round of Counseling.

Government have examined in the matter in detail and are pleased to modify the Clause 11.1.1 as below:

"All candidates included in the Rank Lists/Category Lists of P.G Medical/Diploma courses-2015 prepared and published by the CEE except the candidates who have joined under All India Quota and still holding the seats are eligible to participate in the 3rd round of counseling, which is scheduled as a personal counseling."

Further, it is also ordered that while conducting the 3rd round of Counseling first seat of any Clinical Subject being reverted from All India Quota shall be reserved for Ex-service candidates as specified in Government Order read as 2nd paper above.
