ADMISSION TO P G MEDICAL (DEGREE / DIPLOMA) COURSES, KERALA-2017 SPOT ADMISSION TO VACANT SEATS

A Spot Admission to fill up the vacant seats in P G Medical courses - 2017 in Government/Self Financing Medical colleges and Deemed University will be conducted at 9.30 am on 28.05.2017 (Sunday) at the Old Auditorium inside the Government Medical College campus, Thiruvananthapuram.

As per the letter No. V/11025/18/2017 dated 24/05/2017 from Ministry of Health and Family Welfare, the cut-off criteria for qualifying in NEET-PG has been lowered to 42.5 percentile for general candidates and 32.5 percentile for reserved category candidates. Accordingly, those candidates who have become eligible can register newly by online till 11 pm on 26-05-2017 by clicking the link "Registration" available in 'PGMedical2017-Candidate Portal' and giving "NEET testing ID" and "Date of Birth".

After including the newly registered candidates, a Revised Kerala State Combined Merit list will be prepared by Commissioner for Entrance Examinations and will be published on 27-05-2017, 1 pm. Candidates included in the Revised Kerala State Combined Merit list alone will be eligible for participating in the Spot Admission process. After the publication of the Revised Kerala State Combined Merit list, all candidates in the said rank list can download a **Spot Admission Slip** from the above portal. The Spot Admission Slip is mandatory for a candidate to participate in the Spot Admission process.

Guidelines for Spot Admission

1. The spot admission will be based on the Revised Kerala State Combined Merit list.
2. The spot admission will be manual and as per the provisions contained in clause 10.1.18 of the prospectus for admission to PG Medical courses 2017. A candidate who figures in the Revised Kerala State Combined Merit list prepared for Admission to Medical PG Degree/Diploma Courses-2017 can attend the Spot Admission. Those who are holding All India Quota seats will not be entitled to attend the Spot allotment/admission process.
3. Candidates who have obtained admission in Government merit seats for a subject in any of the Government Medical colleges shall not be eligible to participate in the Spot Allotment/Admission for the same subject in other Government Medical colleges. Similarly candidates who have obtained admission in a course in any of the Self Financing Medical colleges/Deemed University shall not be eligible to participate in the Spot Allotment/Admission for the same subject in other Self Financing Medical colleges. However, a candidate who got admission in a Self Financing Medical College/Deemed University shall be permitted to take admission in the same/different subject in a Government Medical College through Spot Allotment/Admission and vice versa.
4. Transfer from the NRI quota seats to Management or General Quota seats and vice versa are permitted.
5. Candidates (except SC/ST) getting fresh admission to any Government Medical college through spot allotment shall have to produce a Demand Draft for Rs. 45,000/- drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram at the time of allotment. Candidates getting fresh allotment in Private Self Financing College / Deemed University shall have to bring a Demand Draft for Rs. 2,00,000/- drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram. Remaining fee shall have to be remitted in the allotted college.

6. All vacant seats reported by the colleges concerned/DME at 5.30 pm on 26.05.2017 due to non-joining / issue of TC will be included at the spot admission scheduled to be conducted on 28.05.2017. Course once allotted in the spot admission shall be final. Mere surrender/Exchange of seat in the Spot Allotment/Admission will not be allowed.
7. The candidates appearing for the spot admission shall produce the documents in original as in clause 10.2 of the Prospectus to prove their academic eligibility along with the NEET Score sheet and Transfer certificate. However a candidate who is holding any seat allotted during the first or second round of allotment conducted by the CEE need to submit the NEET - PG Score sheet only. Candidates attending the Spot admission should also produce the Spot Admission Slip which can be downloaded from the Candidate Portal after the publication of Revised Kerala State Combined Merit list.
8. The vacancies created at the time of spot admission will be filled up then and there itself according to merit and eligibility.
9. For an SC/ST candidate allotted to a Government Medical College or Government seats in Private Self Financing Medical Colleges/Deemed University, the token amount to be paid at the venue of allotment will be Rs.1000/- (Rupees One Thousand only). However a candidate who has already paid tuition fees to the CEE during the first or second round of allotment need to pay only the balance amount, if any, during this spot admission.
10. Candidates seeking admission under Minority Community Quota in Self Financing Colleges having Minority Status should produce the Community Certificate obtained from the authority concerned in the prescribed format available in the website(for Christian Community). Candidates belonging to Muslim community seeking admission under Minority Community Quota should produce the Community Certificate obtained from the Revenue Authority. Candidates seeking admission under NRI Quota seats in Self Financing Colleges/Deemed University shall have to produce the required documents to prove NRI claim[refer website for details].
11. The newly registered Keralite candidates will be considered for Spot Admission to the Management/Community/NRI Quota seats in Self Financing Medical Colleges and to the seats in Deemed University. The newly registered Non-Keralite candidates will be considered for Spot Admission only to the seats in Deemed University.
12. The claim of the candidates registered newly consequent to the relaxation in qualifying criteria in NEET PG 2017 to the Government seats shall be subject to the verification and satisfaction of documents in proof of the same, at the time of spot admission.

The vacant seats in Government/ Private Self Financing Medical colleges/ Deemed University after the second round of counseling will be published on the website on 27.05.2017.

Representatives of all colleges who are competent to issue Transfer Certificate, if necessary are directed to be present at the venue of Spot allotment/admission at 9AM on 28-05-2017 with out fail. They are also directed to bring all the original documents collected from the students at the time of 1st and 2nd phases of allotment.

Important:

- a) The candidates who are allotted with a seat in the spot admission and who discontinues the course on any reason after this admission shall be liable to pay the liquidated damages as per Clause 13-2 of the prospectus for admission to PG Medical Courses 2017.
- b) The Officials from National Board of Examination, New Delhi will be conducting Bio-Metric Verification of all the admitted candidates in PG Medical course on the day of Spot Admission.
- c) Bio-Metric verification for all other candidates including those admitted under All India Quota seats in Kerala will be held on 30-05-2017, at Bhagyamala Auditorium, Chandrasekharan Nair Stadium, Thiruvananthapuram from 9.30 am onwards.
