ORDER

Vide G.O read above Government have approved the prospectus for admission to M.Sc Nursing Course for the Academic Year 2014-15. As per clause 7.2.2 of the prospectus applicant shall have completed one year of experience on the date of notification of inviting application in any hospital with average bed strength of one hundred inpatients or in a recognized School of Nursing or in a Community Health Centre or Internship/Compulsory Nursing service after registration with the Nursing Council.

As per letter 1st and 2nd read above Director of Medical Education & Honble Justice J.M. James, Chairman, Admission Supervisory Committee & Fee Regulatory Committee for Professional Colleges of Kerala has requested Government necessary amendments to be made in the prospectus 2014-15 for the admission of M.Sc Nursing Course in order to enable the students of the MG University to take part in the admission process.

Government have examined the matter in detail and are pleased to amend clause 7.2.2 of prospectus for admission to M.Sc. Nursing Course for the academic year 2014-15 is as follows:

7.2.2. Applicant shall have completed one year experience on or before 3rd August 2014 in any hospital with average bed strength of one hundred inpatients or in a recognized School of Nursing or in a Community Health Nursing Programme or internship/compulsory Nursing service **after registration with the Nursing Council.** In the case of candidates who are undergoing internship/Experience in the Nursing Colleges/Hospitals of the state, a Certificate from the head of the institution/authority to the effect that he/she will be completing one year internship/experience by **3rd August 2014** should be produced along with the application printout.

The Commissioner for Entrance Examinations, Thiruvananthapuram will take necessary action in the matter.


