POST GRADUATE SUPER SPECIALITY COURSES, KERALA - 2010
CALL FOR DOCUMENTS TO PROVE NATIVITY AS PER ORDER OF
THE HON'BLE HIGH COURT OF KERALA

As per the order of the Hon'ble High Court of Kerala dated 16-07-2010 in WPC No 14908,14981 and other similar WPC's the Clause III (a) (v) of Prospectus for Admission to Post - Graduate Super Speciality Courses , Kerala 2010 is modified as " *Preference shall be given to Indian Citizens of Kerala origin/ Children of all India Services (AIS) officers (non Keralites) allotted to Kerala cadre/ those who had done MBBS/MD/MS from the Medical Colleges in Kerala for preparation of rank lists. In case sufficient number of candidates in the above category is not available for admission for any reason candidates from other states will be considered for the balance seats, based on the merit in the entrance Examinations.*"

Hence the candidates who had appeared for the Post Graduate Super Speciality Entrance Examinations 2010 are directed to produce the proof for Keralite Status in any one of the following certificates duly noting down the Application No., Roll No. and Name of the Candidate so as to reach this office on or before **22.07.2010(Thursday)**. Those candidates who have already submitted Nativity Certificate in the prescribed format need not submit it now.

(i) The true copy of the relevant page of Secondary School Leaving Certificate of the candidate showing the place of birth in Kerala

OR

(ii) The true copy of the relevant page of the Secondary School Leaving Certificate of either of the parents of the candidate showing Place of Birth in Kerala with corroborative certificate to establish the relationship between the parent and the candidate.

OR

(iii) The true copy of the relevant page of the Passport of the candidate, issued by Government of India, showing Place of Birth in Kerala or of either of the parents of the candidate showing Place of Birth in Kerala with corroborative certificate to establish the relationship between the parent and the candidate.

OR

(iv) A certificate of birth from the authority competent to register birth (Panchayat/ Municipality /Corporation) showing the candidate's or either of the parents (in which case corroborative certificate to establish the relationship between the parent and the candidate is necessary) place of birth in Kerala, to be issued by a competent registering authority.

OR

(v) A certificate from the Village Officer/Tahsildar to show that the candidate or his/her father/mother was born in Kerala.

OR

(vi) A certificate from the competent authority showing that the parent of the candidate is an All India Service officer allotted to Kerala cadre.
