FINAL ALLOTMENT TO PROFESSIONAL DEGREE COURSES - 2008

The final allotment to Professional Degree Courses - 2008, based on the options available as on **18.10.2008** has been published. Private Self-financing Ayurveda Colleges have been excluded from the allotment process as per the orders of Government and as per the provisions of the Agreement between the management of these colleges and the Government.

The details of allotment and fee/deposit remitted or to be remitted will be displayed in the home page of the candidates, through the website www.cee.kerala.gov.in/capresult2008. A print out of the allotment letter can be taken from this website. The last rank details of various courses and colleges are also available in the website.

College authorities have to download the list of candidates who have received fresh/re-allotment, from the website www.cee.kerala.gov.in/capcollege and should issue Transfer Certificate, original certificates and deposit collected from candidates who are re-allotted to other courses/colleges based on this allotment within the scheduled time.

Candidates have to remit the amount shown in the home page, at any of the selected branches of the State Bank of Travancore (SBT) during the period **from 23.10.2008 to 25.10.2008** (till 12 noon). Those candidates who have remitted fee/deposit earlier, if re-allotted to a different college/course having a higher fee/deposit, have to remit the balance amount of fee/deposit during the same period. The candidates who fail to remit the fee/balance fee/deposit will lose their allotment.

Candidates who have received allotment have to report in the respective colleges along with the documents specified in *clause 11.7.1* of the Prospectus - 2008, between **28.10.2008 and 30.10.2008**. Candidates, who are re-allotted from

existing admission on 22.10.2008, have to compulsorily report and join the newly allotted college during the same period.


College authorities have to admit the candidates using the website www.cee.kerala.gov.in/capcollege. They should forward the non-joining report of candidates to the Commissioner for Entrance Examinations through fax (No. 0471 -2337228) positively on 31.10.2008.

The admission to all Professional Degree courses will come to a close on 31.10.2008. Candidates who want to discontinue studies or cancel admissions after closing of admission are liable to pay liquidated damages as per *clause* 12.2.4 of the Prospectus.
