**ALLOTMENT TO INTEGRATED FIVE YEAR LL.B COURSE 2020-21**  
**THIRD PHASE OF ALLOTMENT PUBLISHED**

The Third Phase of Centralised Allotment (CAP) for admission to Integrated Five Year LL.B Course in the Government Law Colleges and Private Self-financing Law Colleges of the State for the year 2020-21 is published herewith in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment is based on the online options registered by candidates up to **5.00 PM on 06.10.2020**. Seats reserved under Sports quota are also allotted in this phase.

Candidates can access their homepage by entering their Application number, and Password in the '**Integrated Five Year LL.B 2020- Candidate Portal**' provided in the above website. Then by clicking the menu item '**Allotment Result**', candidates can view their Allotment details. Candidate can download their Allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc. are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment Memo. Candidates can also log into their Home page and click the Menu item '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive fresh allotment or a change in allotment than the previous phase shall have to take a print out of the Allotment memo and remit the fee, if shown in the Allotment Memo to be paid to the Commissioner for Entrance Examinations by way of Online Payment or at any of the Head Post Office in Kerala and should report for admission before the Principal of the allotted colleges on any date from **12.10.2020 to 16.10.2020, 3.30 pm** along with the Allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the balance fees, if any, as per Government orders in the allotted college at the time of admission.

Candidate belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O.(Ms)NO.25/2005/SCSTDD. dated.20.06.2005/Children of Fisherman/Inmates of Sree chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

Candidate who got allotment under EWS Quota in Govt. Law Colleges and private Self-financing shall have to pay the prescribed fee applicable to respective colleges.

**Note: Candidates who got allotment are instructed to appear for admission at the respective college before 3.30 pm as the working time of the law colleges is set as 8.30 am to 3.30 pm on account of Covid-19 regulations.**

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **4.00 pm on 16.10.2020**

If seats are vacant even after the third phase of allotment process a Mop-Up allotment will be conducted to fill the seats. Detailed notification in this regard will be issued later.
