Allotment to Engineering/Architecture/Pharmacy Courses -2020 **Admission Schedule**

Those candidate who have got an allotment as per the second phase allotment to Engineering/Pharmacy courses and the first phase allotment to Architecture courses published on 23.10.2020 should remit the fees/balance fees (if applicable) to be paid to Commissioner for Entrance Examinations from 24.10.2020 to 31.10.2020, 4.00 PM through online payment or through any of the Head Post Offices in Kerala and should report to the concerned colleges mentioned in the allotment memo to take admission as per the schedule published in the website www.cee.kerala.gov.in. The admission schedule is also published in the website of the concerned colleges. The candidates who have got allotment should visit the website of the concerned colleges and should also contact the concerned college before taking admission. The instructions for taking admission in Government /Aided engineering colleges, prepared by the DTE is published in the website of Commissioner for Entrance Examinations. Those students who have got an allotment in Government/Aided Engineering colleges should go through the instructions published in the website before taking admission, to concerned colleges.

In view of Covid-19 pandemic situation, any allotted student, who cannot take admission physically as per the schedule, can ensure admission either virtually or through the method suggested by the college authorities after contacting the concerned colleges. Those candidates who have got allotment in Government/Aided Engineering colleges can take admission by surrendering their documents including TC in the Government/Aided colleges/Institutions (shown in Annexure I) or as suggested by the colleges authorities.

Candidates who have got allotment in Self-financing colleges should remit the fee/balance fees (if applicable) to be paid to Commissioner for Entrance Examinations from **24.10.2020 to 31.10.2020, 4.00 PM** through online payment or through any of the Head Post Offices in Kerala and should report to the concerned colleges either physically or virtually or as suggested by the concerned college authorities.

Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time (including candidates eligible for fee concession) will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.
