ALLOTMENT TO PG MEDICAL (DEGREE) COURSES, KERALA-2020 SCHEDULE FOR FIRST PHASE OF ALLOTMENT

The activities related to the first phase of centralized allotment to Post Graduate Medical Degree Courses for the year 2020 will commence from **13/04/2020 (Monday)**.

All the eligible Candidates including Service candidates and the candidates under PwD Quota who have applied for admission to PG Medical Courses 2020 in the State can register their options online through the Website www.cee.kerala.gov.in from 13.04.2020 to 18.04.2020, 3 pm.

Candidate shall have to click 'PGMedical2020-Candidate Portal' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options online by clicking the menu item '**Option Registration**' available in the home page.

Provisional rank list/category list for the course will be published later. The above said list will be strictly provisional as the list will be prepared based on the claims made by the candidates through their online application. The candidates will be provided with the facility to verify and rectify any defects if any in their profile details in due course, however all the candidates applied for admission to PG Medical Courses 2020 in the State can register their options online from **13.04.2020**. Till the rectification of the defects, the allotment if any given to the candidate will be provisional. The provisional allotment of the candiate will be cancelled if they fail to upload the required documents to correct the defects through the above web site before the second allotment.

The schedule for the allotment is given below:

The list of Medical Colleges/Courses to which the Commissioner for Entrance Examinations makes allotment is provided in the Home page of the candidate. Candidates can give options as per their priority of the Course-College combinations in the option list. A candidate need only give options to a Course-College combination if he/she is sure to join the course and college, under the chosen quota, if allotted. Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post/Fax/E-mail will not be processed /considered for allotment to the courses.

Candidates who seek admission under Minority/NRI quota in Self Financing Medical Colleges shall have to register options online to the desired courses/colleges along with other students during the time of online option registration for first phase itself.Candidates who do not register options shall

not be considered for allotment under Minority/NRI/Service Quota even if they are included in the respective category lists. As the minority and NRI quota status of the candidates are not finalized, at this stage, candidates are allowed to choose all the available course-college-quota combination. However, options under NRI and Minority quota will be considered for allotment only if the candidate is found eligible for the respective quota based on the documents uploaded with the online application.

The directions regarding remittance of fees as prescribed, and joining at the colleges for the candidates allotted to courses will be issued later.
