**THIRD PHASE OF ALLOTMENT TO  
ENGINEERING/ARCHITECTURE/PHARMACY COURSES  
ONLINE OPTION CONFIRMATION IS MANDATORY**

The activities related to the third phase of allotment to Engineering, Architecture and Pharmacy Courses -2018 commenced on **16.07.2018**. Government have accorded sanction to the Commissioner for Entrance Examinations to make allotment to the seats available for allotment by Government in B.Pharm course in Academy of Pharmaceutical Sciences, Pariyaram, Kannur. Also, as per orders dated 10.07.2018 in WP(C) No. 17848/2018, the Hon'ble High Court have ordered to include Shahul Hameed Memorial Engineering College, Kadakkal, Kollam in the allotment process. In the third phase, allotment will be done to these newly included Engineering/Pharmacy colleges also.

**Online Option Confirmation:**

The Candidates who want their higher order options in Engineering, Architecture and Pharmacy courses to be considered in the second phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges from **16.07.2018 to 19.07.2018, 10 am**, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). On the basis of options received up to **10 am on 19.07.2018**, the third phase allotment to Engineering, Architecture and Pharmacy courses will be published in the evening on **20.07.2018**.

Candidates who receive allotment in the third phase shall have to take a printout of their third phase allotment memo and remit the fee/ balance fee (if applicable) payable to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **21.07.2018 to 25.07.2018**. The list of Post Offices having facility for fee payment is available in the website. After remitting the fee/balance fee, the candidates should join the course/college allotted in the second phase before 5 pm on 25.07.2018. The "Facilitation Centres" [FC] having internet facility, will be functioning throughout the State during this period for providing necessary help to the candidates for registration of options. **DETAILED SCHEDULE FOR THE THIRD PHASE OF ALLOTMENT**

16.07.2018	Website opens for <b>Online Option Confirmation</b> and for enabling re-arrangement of higher options/deletion of unwanted options and registration of fresh options to the newly added Courses/Colleges.
19.07.2018 (10 am)	Time for Online Option Confirmation and re-arrangement/deletion/addition of options ends
<b>20.07.2018</b>	<b>Publication of Third Phase Allotment</b>
21.07.2018 to 25.07.2018	Candidates who receive allotment should remit the fee/balance fee (if applicable) payable to CEE in any of the Head Offices in Kerala or by way of online payment and should report before the college authorities to join the allotted college/course.
25.07.2018 (5 pm)	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System ( <b>OAMS</b> ).

**Those who do not confirm their options online will not be considered for the third phase allotment and also their higher order options in Engineering, Architecture and Pharmacy streams will not be available in the subsequent phases. However his/her existing allotment shall be retained if he/she has joined the course/college as per the second phase allotment. Online Option Confirmation is mandatory for being considered in the third phase of allotment to Engineering, Architecture and Pharmacy Courses for both candidates allotted with a course in the second phase and those who have not received any allotment in the second phase.**

The following Engineering/Pharmacy colleges concerned have been newly included in the third phase of allotment, for which fresh options can be filed by candidates.

**Token Deposit :**

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have to remit token deposit of Rs. 1000/- to the Commissioner for Entrance Examinations as token of having accepted the allotment and should join the college allotted on any date from 21.07.2018 to 5 pm on 25.07.2018.

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies, Affiliation from the Universities and Government Orders.

The third phase of allotment will be the last phase of allotment to Private Self Financing Engineering/Architecture colleges. The availability of higher options to the students allotted to Private Self Financing Engineering and Architecture colleges shall be as per the Government orders- GO(MS) No. 166/2017/H.Edn dated: 22.06.2017, GO(MS) No. 107/2018/H.Edn dated: 21.05.2018 & GO(MS) No. 108/2018/H.Edn dated: 21.05.2018. Hence all the candidates are instructed to go through and satisfy themselves regarding the conditions in the above Government Orders.

**Note:**

- 1) Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
- 2) The candidates whose results in the respective rank lists have been withheld due to various reasons can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they produce the required documents to clear the defects and release their ranks before 5 pm on 18.07.2018.
