## **NOTIFICATION**

## ALLOTMENT TO PG AYURVEDA (DEGREE/DIPLOMA) COURSES—2020 FACILITY FOR OPTION CONFIRMATION AND REGISTRATION

- PG AYURVEDA(DIPLOMA) COURSES HAVE BEEN NEWLY INCLUDED IN THIS PHASE.
- CENTRALIZED ALLOTMENT PROCESS FOR DEGREE AND DIPLOMA COURSES COMBINED.
- ONLINE OPTION CONFIRMATION IS MANDATORY FOR BOTH THE HIGHER OPTIONS REMAINING AFTER THE FIRST PHASE AND THE FRESH OPTIONS TO THE DIPLOMA COURSES INCLUDED IN THIS PHASE. CANDIDATES WHO WERE NOT ALLOTTED A SEAT IN THE FIRST PHASE SHOULD ALSO DO OPTION CONFIRMATION IF THEIR OPTIONS ARE TO BE CONSIDERED IN THIS AND SUBSEQUENT PHASES. FAILURE TO DO ONLINE OPTION CONFIRMATION IN A PARTICULAR PHASE OF THE CENTRALIZED ALLOTMENT PROCESS WILL LEAD TO CANCELLATION OF THE OPTIONS NOT ONLY FOR THAT PHASE BUT FOR THE SUBSEQUENT PHASES ALSO.

The activities related to the second phase of centralized allotment to PG Ayurveda courses for the year 2020 will commence from 16/01/2021. This phase of allotment will be done for the second phase allotment to the courses in various Ayurveda Colleges included in the first phase of allotment and to the newly included diploma courses in four Govt/Aided Colleges. Candidates who have already got allotment in Ayurveda Colleges through the first phase of allotment can confirm online options to be considered for second phase of online allotment. Based on G.O(Rt) No. 9/2021/AYUSH, dated 07.01.2021, candidates were allowed to apply for the PG Ayurveda (Diploma) course in four Govt/Aided Colleges, and subsequently the rank order list for PG Ayurveda (Diploma) courses - 2020 has been prepared and published. Candidates who figure in the rank list for PG Ayurveda (Diploma) courses - 2020 are eligible to register fresh options for the newly included courses in this phase of Allotment.

Online Option Confirmation is mandatory even if no fresh options are to be registered. So, all the candidates except those who are satisfied with their current admission must login to the candidate portal and confirm the options if they want to participate in this and subsequent phases of the Centralized Allotment Process(CAP). In each phase of the Centralized Allotment Process, a separate Online Option Confirmation step is included. Failure to perform the Online Option Confirmation step at a particular phase of the CAP will lead to the cancellation of the options not only for that phase but for the subsequent phases also.

The Candidates who want their options in PG Ayurveda courses to be considered shall have to log into their Home Page available in 'PG Ayurveda (Degree/Diploma) 2020 - Candidate Portal' and confirm their options by clicking the 'Confirm' button

available therein. After Online Option Confirmation, candidates can re-arrange their higher order options or delete the unwanted options and Register fresh options to the newly included PG Ayurveda(Diploma) courses from 16.01.2021 to 21.01.2021, 03.00 pm, through the website www.cee.kerala.gov.in. Online option confirmation is mandatory for those who have got admission and those who have no allotment in the previous phase of the Centralized Allotment Process (CAP) for PG Ayurveda Courses conducted by the Commissioner for Entrance Examinations to consider their options in this and subsequent phases of the CAP. But for those who do not confirm their options, the admission in the prior phase shall be retained. Candidates who are included in the rank list for PG Ayurveda(Diploma) Courses 2020 can register fresh options for PG Ayurveda(Diploma) Courses. Candidates who are included in the rank lists for both Degree and Diploma courses have to combine their options into a single list ordered according to their respective preferences for each of the available options. On the basis of options received up to 21.01.2021, 03.00 pm, the allotment will be published on the website www.cee.kerala.gov.in on 22.01.2021.

## The schedule for the second phase of allotment is given below:

16.01.2021	Website opens for Online Option Confirmation and for enabling rearrangement of higher options/deletion of unwanted options and registering of fresh options.
21.01.2021 3:00 PM	Time for Online Option Confirmation and re-arrangement/deletion and registration of options ends.
22.01.2021	Publication of Allotment.
23.01.2021 to 29.01.2021 3:00 PM	Report to the Allotted College, complete Admission formalities and join the college.
29.01.2021 4.00 PM	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for PG Ayurveda course.

Candidates allotted to a course/college should remit the fee mentioned in the allotment slip at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not complete the admission formalities within the stipulated time will lose their allotment as well as the claims for further allotments, if any. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home need not remit fees.
