## PREPARATION OF ENGINEERING RANK LIST 2017 MARKS DATA SUBMITTED BY CANDIDATES PUBLISHED FOR VERIFICATION

The candidates who have qualified in the Engineering Entrance Examination 2017 were directed to submit the marks obtained for the Subjects concerned in the Second year of Plus Two or equivalent Qualifying Examination through the website <u>www.cee.kerala.gov.in</u> from 27.05.2017 to 08.06.2017 for the preparation of Engineering Rank list 2017. The candidates whose marks populated in the web page are the same as the marks shown in the mark sheet were directed to verify and finalize the data online. Those who had to edit/enter the marks in the web page during the mark submission were directed to submit the duly signed copy of the printout of 'Mark Data Sheet' and self attested copies of mark sheets of Qualifying Examination on or before 09.06.2017 to the Commissioner for Entrance Examinations for the preparation of Engineering Rank List 2017.

Accordingly the marks data submitted by the candidates have been scrutinized and is published in the website <u>www.cee.kerala.gov.in</u> for verification. The mark data will be available for verification in the website up to 5pm on 13<sup>th</sup> of June 2017. Candidates have to enter their homepage by giving their Application Number and Password through the link <u>KEAM 2017 Candidate Portal</u>. Then by clicking the Menu Item 'Mark Verification', they can see the marks data submitted by them for the preparation of Engineering Rank List-2017. The Candidates may verify their Board of Qualifying Examination, the marks obtained for each subject, the Maximum marks and Year of Passing for ensuring its correctness.

- If the details are correct, click the 'No Change' button against each item and finally click the 'Verified and Found Correct' button. Such candidates need not send any documents to the Commissioner for Entrance Examinations.
- If any of the details shown in the web page is/are incorrect, click the 'Change Required' button against the item to be corrected and then click the 'Verified and Found Mismatch' button. Then take the printout of 'Proforma for Change in Mark Data' and fill up the correct details in it. The signed copy of this printout along with self attested copies of mark lists are to be send to the <u>Commissioner for Entrance Examinations</u>, <u>5<sup>th</sup> Floor</u>, Housing Board Buildings, Santhi Nagar, Thiruvananthapuram 695 001 so as to reach him on or before 5 pm on 14.06.2017.
- The printout of Mark Data Sheet and copy of Mark lists of some of the candidates who had edited/entered the marks in the web page during the submission of marks in the Qualifying Examinations have not been received in this office. Also some of the printouts received in this office from the candidates who had edited/entered the marks in the web page during the submission of marks in the Qualifying Examinations were not supported with the copy of mark lists and in some cases, the supported mark lists were defective in nature. These candidates, on clicking the menu item Mark Verification can see a Memo showing the defect in their procedure of mark submission. Such candidates should take the printout of 'Mark Data Sheet' and a signed copy of this printout along with self attested copies of mark lists are to be sent to the Commissioner for Entrance Examinations so as to reach him on or before 5 pm on 14.06.2017. The results of those candidates who do not submit the required documents to rectify the defects in their procedure for mark <u>submission will be withheld</u>.

Requests for correction in marks will not be entertained under any circumstances after 14.06.2017. The marks data as on 14.06.2017 will be used for the preparation of Engineering Rank List-2017, after considering the genuine complaints, if any, received from the candidates. The marks data of the candidates who do not verify the marks online or follow the steps to correct the defects in their submitted marks will be used as such for the preparation of Engineering Rank List-2017.

The Mark Data submitted by the candidates will be subjected to verification by the College Authorities at the time of Admission to the Courses. If any discrepancies are found in the Mark Data submitted by the candidate, he/she will not be eligible for admission to the courses.
