Results Published

The Provisional Rank list of General candidates and the results of service candidates who have appeared for the Entrance Examination for admission to P G Medical Course 2015 conducted on 08.02.2015 at Thiruvananthapuram, Ernakulam and Kozhikkode centres are published herewith.

Dr. KUKKU S MATHEW, Nandanam, House No.7 Bridge Lane, Ulloor, Medical College P O, Thiruvananthapuram (Roll No.56150) has secured the first rank in this Entrance Examination.

The Answer Keys to the questions were published on 10.02.2015. A few complaints regarding the questions / keys have been received and the same have been examined by Expert Committee constituted for the purpose. Based on the recommendations of the Committee, in Paper I (Version A) Question numbers 11, 41, 45, 49, 52, 53, 56, 57, 58, 60, 81, 131, 143 and 145 are deleted and key of Qn. No. 54 changed as A, and Qn. No. 112 changed as C. in Paper I (Version B) Question numbers 37, 49, 51, 67, 97, 101, 105, 108, 109, 112, 113, 114, 116 and 137 are deleted and key of Qn. No. 18 changed as C, and Qn. No. 110 changed as A. Also in Paper II (Version A) Question numbers 94, 111 and 125 are deleted and in Paper II (Version B) Question numbers 14, 31 and 45 are deleted.

While preparing the rank list, in Paper I 14 questions have been deleted since there were more than one correct choice for the questions/ambiguous questions. These questions have not been included for valuation and no marks have been awarded for these deleted questions to any candidate. The marks obtained for the remaining 136 questions have been multiplied by (150/136) to get the actual marks (corrected to four decimals). Also in Paper II 3 questions have been deleted since there were more than one correct choice for the questions/ambiguous questions. These questions have not been included for valuation and no marks have been awarded for these deleted questions to any candidate. The marks obtained for the remaining 147 questions have been multiplied by (150/147) to get the actual marks (corrected to four decimals). The above formulae are applied to award proportionate marks based on the scores of the candidates in the questions considered for valuation (excluding deleted question) to compensate the loss of marks for the deleted question.

The Provisional Rank list of General Quota candidates and the Result of Service Quota candidate will be available for reference in this office and on the website www.cee-kerala.org. The final rank list of Health Service Quota candidates who qualified in the Entrance Examinations will be published by the Commissioner for Entrance Examinations after awarding the due weightage of marks for the rural service furnished by the Director of Health Service (DHS) as per the GO(Rt) No. 517/2015/H&FWD dated: 03.02.2015.

Inclusion of a candidate in the rank list does not entitle him/her for admission to the courses, unless he/she satisfies the eligibility conditions contained in the Government approved Prospectus. The Commissioner for Entrance Examinations will make allotment and admissions as per the conditions laid down in the Prospectus.
